An internet resource which provides access to full text, scientific and scholarly journals.

DiVA

An institutional repository for research publications and student theses written at 28 universities and colleges of higher education (Scandinavian focus).

DRIVER

Provides access to European theses and dissertations.

Ethos: theses repository of British Library

Provides access to theses produced by UK Higher Education institutions.

Google Scholar

An internet resource that provides access to scholarly literature across various disciplines and sources, including theses, books, abstracts and articles.

Hein Online

Contains full-text law reviews from most US law schools, some international journal archives, US legal materials and some international legal materials. Features more than 1,400 law and law-related periodicals.

Hogan Lovells library catalogue

Catalogues of Hogan Lovells' UK, Dutch, German, Polish and US libraries.

Index to Foreign Legal Periodicals

A subject index to selected international and comparative law periodicals and collections of essays. Provides coverage of public and private international law, comparative and foreign law and the law of all jurisdictions other than the United States, UK, Canada and Australia.

Index to Theses

A listing of theses with abstracts accepted for higher degrees by universities in the UK and Ireland.

IngentaConnect

Provides access to collections of academic and professional research articles online. Features over 13,500 publications.

Institute of Advanced Legal Studies (IALS) catalogue

The library catalogue of the IALS, a postgraduate legal research institute, attached to the University of London.

IP Law 360

News source that provides access to current articles on IP written by experts in the field. Includes stories on current issues, new decisions, settlements and practice profiles.

JSTOR

Provides online access to scholarly articles. Includes over 1,000 leading academic journals across the humanities, social sciences and sciences.

Lexis.com

A database that provides access to legal, news and business information. Files searched for the purposes of this study:

- *Index to Legal Periodicals* - Provides an index to articles from more than 500 legal journals, yearbooks, institutes, bar association organisations, university publications, law reviews and government publications. The items originate from the UK and Ireland, among other countries.
- *Law Reviews, Legal Journals & Periodicals, Combined* - Contains: US law reviews and journals, Canadian law reviews, ABA journals and bar journals.
- *Legal Resource Index* - Provides an index of substantive articles and reviews related to the legal profession selected from over 700 legal resources.

Provides access to publications from the repositories of Dutch universities and research institutes.

Nexis

A global business information research database. Files searched for the purposes of this study:

ABI Inform - Contains selected full-text and abstract documents from over 1,000 business publications.
Mega News - Contains full-text and selected abstract news sources.

Practical Law Company – PLC

A provider of legal know-how and market intelligence for lawyers. Content consists of practice notes and updates with practical analysis. The service includes all articles from PLC Magazine.

SCIRUS ETD

Features journal content and institutional repository and website information.

Specialist websites – Wildy & Sons, Hammicks, Blackwell
