Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002 (hereinafter referred to as the 'Financial Regulation') ¹, and in particular Article 133 thereof,

Having regard to Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union (hereinafter referred to as the 'Rules of Application')², and in particular Article 204 thereof,

Having regard to Regulation No 1382/2013 of the European Parliament and of the Council of 17 December 2013 establishing a Justice Programme for the period 2014 to 2020³, and in particular Articles 4 (1) (a) and (c) thereof,

Whereas:

- (1) The Commission adopted the 2014 Commission Implementing Decision concerning the adoption of the work programme for 2014 for the implementation of the Justice programme⁴, which provides for two calls for 3-year Framework Partnership Agreements (2015-2017) to support European networks active in the area of facilitating and promoting judicial cooperation in civil and/or criminal matters and in the area of access to justice;
- (2) A call for proposals has been published on the internet site of the Directorate-General for Justice under the reference JUST/2014/SPOB/OG/NETW, which implements all abovementioned activities of the Annual Work Programmes and establishes the objectives and priorities and the admissibility, eligibility, exclusion, selection and award criteria;

- (3) The same call established also the objectives and priorities and the selection criteria for selecting Framework Partners in the areas of the Rights, Equality and Citizenship Programme and awarding Operating grants 2015 to them. The present award decision does not reflect the results of that evaluation;
- (4) The Evaluation Committee established an Evaluation Report, which contains all the information required under Article 204(4) of the Rules of Application;
- (5) The implementation of all Framework Partnership Agreements awarded under this call must be done in accordance with the provisions of the Guide for Operating Grants to Framework Partners, published on the call website.

I hereby decide:

Article 1 Selected proposals

The proposals listed in Annex 1 to this Decision shall be awarded a Framework Partnership Agreement under the call for proposals JUST/2014/SPOB/OG/NETW, and more specifically for the priorities: JCOO-Judicial cooperation in civil and/or criminal matters & JACC-Access to justice.
