THE EUROPEAN COMMISSION,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002 (hereinafter referred to as the 'Financial Regulation')<sup>1</sup>, and in particular Article 133 thereof,

Having regard to Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union (hereinafter referred to as the 'Rules of Application')<sup>2</sup>, and in particular Article 204 thereof,

Having regard to Decision No 779/2007/EC of 20 June 2007<sup>3</sup> of the European Parliament and of the Council establishing for the period 2007-2013 a specific programme to prevent and combat violence against children, young people and women and to protect victims and groups at risk (Daphne III programme), and in particular, Article 4(b) thereof,,

Whereas:

- (1) The Commission adopted the financing decision for 2013 of the specific programme "DAPHNE III"<sup>4</sup>, which aims to co-fund transnational projects through a call for proposals for action grants under the budget line 33 02 05;
- (2) The call for proposals JUST/2013/DAP/AG was published with a deadline of 30 October 2013, prolonged until 31 October 2013;
- (3) An Evaluation Committee was appointed pursuant to Article 204(1) of the Rules of Application in order to evaluate the applications submitted under the above mentioned call for proposals and to identify the proposals which may receive funding;
- (4) The Evaluation Committee established an Evaluation Report which contains all the information required under Article 204(4) of the Rules of Application;
- (5) The Committee established by Article 10 of Regulation No 1381/2013/EU of the European Parliament and of the Council has been consulted according to Article 15 of the same Regulation under the advisory procedure on the proposed award of grants pertaining to the DAPHNE III programme and has given a favourable opinion;

HAS DECIDED AS FOLLOWS:

*Article 1 Selected Proposals*

The proposals listed in Annex 1 to this Decision shall be awarded a grant under the "DAPHNE III" programme– call for proposals JUST/2013/DAP/AG, up to the maximum amount indicated in that Annex. The overall amount of financing provided is **EUR 11 136 395,38**;

*Article 2 Reserve list*

The proposals listed in Annex 2 to this Decision shall be awarded a grant under the "DAPHNE III" programme – call for proposals JUST/2013/DAP/AG, up to the maximum amount indicated in that Annex, subject to the availability of funds;

*Article 3 Non Selected Proposals*

The proposals listed in Annex 3 to this Decision are not selected for financing under the "DAPHNE III" programme– call for proposals JUST/2013/DAP/AG.
