THE EUROPEAN COMMISSION,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002 (hereinafter referred to as the 'Financial Regulation')¹, and in particular Article 133 thereof,

Having regard to Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union (hereinafter referred to as the 'Rules of Application')², and in particular Article 204 thereof,

Having regard to Decision No 1672/2006/EC of the European Parliament and of the Council of 24 October 2006 establishing a Community Programme for Employment and Social Solidarity - Progress³, and in particular Article 11(1)(b) thereof,

Whereas:

- (1) The Commission adopted the 2012 Commission Decision adopting DG Justice's annual programme of grants and contracts for the Progress programme, serving as a financing decision for 2012⁴, which foresees under budget line 33 06 01 a call for proposals to support national activities aiming at combating discrimination and promoting equality.
- (2) A call for proposals for action grants was published on the internet site of the Directorate-General for Justice under the reference JUST/2012/PROG/AG/AD.
- (3) An Evaluation Committee was appointed pursuant to Article 204(1) of the Rules of Application in order to evaluate the applications submitted under the above mentioned call for proposals and to identify the proposals which may receive funding.
- (4) The Evaluation Committee established an Evaluation Report which contains all the information required under Article 204(4) of the Rules of Application.
- (5) The Committee established by Article 13 of Decision No 1672/2006/EC of the European Parliament and of the Council of 24 October 2006 has been consulted under

the examination procedure according to Article 13(2) of the same Decision and has given a favourable opinion.

HAS DECIDED AS FOLLOWS:

Article 1 Selected Proposals

The proposals listed in Annex 1 to this Decision shall be awarded a grant under the programme "PROGRESS" – call for proposals JUST/2012/PROG/AG/AD, up to the maximum amount indicated in that Annex. The overall amount of financing provided is **4.543.755,80 €(Total amount)**.

Article 2 Reserve List

The proposals listed in Annex 2 to this Decision shall be awarded a grant under the programme "PROGRESS" – call for proposals JUST/2012/PROG/AG/AD, up to the maximum amount indicated in that Annex, subject to the availability of funds.

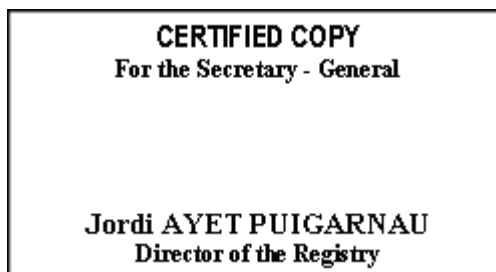
Article 3 Rejected Proposals
