### WORKSHOP 3

**The reform of the Common Fisheries Policy as part of the Integrated Maritime Policy**

**(19 May, 9.00-10.55)**

#### **Rationale:**

Fisheries is an important contributor of food and in some coastal communities also an important economic activity. The Common Fisheries Policy has not achieved all objectives regarding sustainable fisheries and the policy needs to be further integrated with other maritime activities. A consultation on the Common Fisheries Policy reform was launched with a Green Paper in April 2009 which will be the basis for formulating reform proposals leading to a new policy being in place from 2013. This debate around the Green paper on the CFP should cover discussion on possibilities for improved fisheries management in the future and links between fisheries and regional development, spatial planning, economic and social issues, environmental protection or climate change.

Re-thinking the Common Fisheries Policy therefore requires taking a fresh look at the broader maritime picture, in line with the approach advocated by the Integrated Maritime Policy (IMP).

Ocean and sea atlases are powerful and wonderful tools to develop and present Integrated Maritime Policy. Like this new European policy, they can encompass all aspects of the oceans and seas in a holistic and integrated approach, from geographical features to political, economic, social and environmental ones. They can help to maximise the sustainable use of the oceans and seas, with the involvement of the various stakeholders. As announced in the Maritime Policy Blue Book, the Commission will launch a European Atlas of the Seas by the end of 2009, as educational tool to highlight our common maritime heritage and provide a spatial guide to maritime features and EU policies.

The objective of this session is to explore how ocean and sea atlases can inspire public authorities and stakeholders to move further on the path of a more integrated maritime Europe. Authors of main maritime atlases, from book to multimedia formats, from a local to a worldwide scope, will present the process, the result and the impacts of their projects. Learning and recommendations for a more integrated maritime Europe will be discussed.

**Scientific input to the integrated management of sea basins**

In the past years, marine science and oceanography have achieved considerable progress, using observation and modelling, in understanding the impact of human activities on the marine environment in sea basins. This has resulted in important outcomes that are relevant for policy makers who seek to promote an integrated management of sea basins, with a view to promote their sustainable development. The workshop will seek to present these results in simple terms to policy makers who often don't know them, by focusing on two areas: the Baltic (results from the BONUS programme) and the Mediterranean (results from the SESAME project). It will also give the perspective of the industry and in particular that of the maritime transport and oil & gas sectors.

The workshop will therefore focus on the marine science / policy interface on one hand and the marine science / maritime industries on the other hand.

### **WORKSHOP 9**

**Progress towards a European Maritime Transport Space without Barriers**  
(19 May, 11.05-13.00)

#### **Rationale:**

The objective of the European maritime transport space without barriers is to make maritime transport more efficient by abolishing administrative formalities for Community goods at their arrival and at departure from EU ports. It will achieve the internal market in maritime transport. The Commission identified a number of actions contributing to this objective. Amongst the measures to be taken at EU level, the most important one will be the simplification for customs procedures for short sea shipping vessels. The generalisation of enhanced electronic data transmission systems for administration to business communication and the creation of administrative single window at national level will facilitate further the overall administrative procedures.

The objective of the workshop is an exchange of views between shipping companies, ports, shippers and national public administrations on the best way for implementing these short and medium term measures and maximising their positive effects for maritime trade.

Maritime Surveillance is the effective understanding and comprehensive management of anything associated with the maritime domain that could impact the security, safety, trade, economy or environment of the European Union.
