

Privacy Statement for the Registration form
"FP7 Energy Research Information Day – 2011 calls"
Brussels, 8 July 2010

1. Objective

This Registration form offers you an online electronic registration for the above mentioned *meeting*. While registering your personal data will be collected and further processed for the purposes detailed hereafter and potentially published on the Internet, under the responsibility of the Head of the Unit C2, Directorate-General for Energy, acting as the Controller.

As this online service collects and further processes personal data, Regulation (EC) 45/2001, of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the EU institutions and bodies and on the free movement of such data, is applicable.

2. What personal information do we collect and through which technical means?

Identification Data

The personal data collected and further processed are data necessary for the participation in the *meeting*, such as name/surname/profession/postal and e-mail addresses/phone number/fax number/etc. The *meeting* may be broadcast live. Videos and/or photographs of participants may be recorded and stored on the Internet. A list of participants, including name, organisation and e-mail address may be shared among participants and may be stored on the Internet as well.

The processing operations on personal data linked to the organisation and management of this *meeting* are necessary for the management and functioning of the Commission, as mandated by the Treaties, and more specifically articles 5, 7 and 211 - 219 of the EC Treaty.

Technical information

The system uses session "cookies" in order to ensure communication between the client and the server. Therefore, your browser must be configured to accept "cookies". However, it does not collect personal or confidential information of any kind, nor any IP address from your PC. The cookies disappear once the session has been terminated.

3. Who has access to your information and to whom is it disclosed?

Some of your personal data (Photographs and videos of participants and organizers, name/surname/organisation/e-mail address) may be published on the web. If you do

not agree with this publication of your personal data, please opt-out where required or inform the data controller by using the Contact Information below.

The full access to all personal data as well as all information collected in the context of this *meeting*, and the organisation thereof, is only granted through User-Id/password to a defined population of users, without a prejudice to a possible transmission to the bodies in charge of a monitoring or inspection task in accordance with the EU legislation. These users typically are: the organising team of the *meeting* from DG ENER and DG RTD, and DG ENER's subcontractor (Media Consulta Event GmbH), acting as processors.

4. How do we protect and safeguard your information?

The collected personal data and all information related to the above mentioned meeting are recorded in a secured and protected database hosted by the Data Centre of the European Commission, the operations of which abide by the Commission's security decisions and provisions established by the Directorate of Security for this kind of servers and services and on computers of the external contractor acting as a processor, who has to guarantee the data protection and the confidentiality required by the regulation (EC) 45/2001.

5. How can you verify, modify or delete your information?
