#### **ASEAN-EU Year of STI 2012**

The ASEAN-EU Year of Science, Technology and Innovation 2012 was officially launched on 16 November in Hanoi, Vietnam, by EU Ambassador Franz Jessen and the Vietnamese Deputy S&T Minister Lê Din Tiên, in the presence of several Ambassadors from EU Member States and high-level officials from the ASEAN Member States. overall objective of the Year is to highlight, promote and extend EU-Southeast Asia STI cooperation. The 'Year' is the first of its kind, in which EU bi-regional cooperation with an emerging will be highlighted. Full information on activities under the Year will be regularly updated on a dedicated website. DG RTD will be involved in a series of activities in support of the 'Year' including during the visit of Commissioner Máire Geoghegan-Quinn to Singapore in March 2012.

#### **SIRIC Discusses new international strategy**

The SIRIC (Strategic International Research and Innovation Cooperation coordination group) will act the Commission Inter-Service Group as discussing the upcoming Communication Enhancing and Focusing International Cooperation in Research and Innovation. Based on a provisional on 22 November, the Commission Directorates-General and services welcomed the general approach and the links with Horizon 2020 and the ERA Framework. Clear and operational recommendations are expected to bring added-value to the work already carried out by the operational Directorates, including on thematic and geographic priority-setting. Coherence with relevant ongoing or planned Commission initiatives (e.g. work on the post-2013 external funding instruments and the EEAS Country Strategies) is expected to maximise the final impact. There was strong support for consulting widely external stakeholders, particularly industry and civil society. The next discussion by SIRIC will be in March.

# Joint Committee meeting with Brazil

The fifth EU-Brazil Joint Committee meeting took place on 22 November in Brasilia. Discussions took place in the areas of innovation, ICT, environment, social sciences and humanities and food, agriculture and biotechnology research, as well as researcher mobility. The following outcomes were agreed: to improve cooperation on environment and climate change by linking research networks especially in fields such as the mitigation and adaption to climate

change, prevention of natural hazards and the green economy; the involvement of Brazil and other Latin American countries in a partnering initiative on biodiversity in agriculture which is being developed by the EU; and improved dissemination of information on researcher mobility programmes including 'Science without borders' and the EU Marie Curie, Erasmus Mundus and Euraxess programmes, including through a seminar to be held in 2012. In order to deepen cooperation in ICT research it was agreed to develop a second coordinated call, building on the success of the first such call launched in 2010. Finally, it was also agreed to explore the possibility of creating networks between European and Brazilian social science and humanities research funding agencies.

# **Increasing cooperation with Mexico**

The fifth Joint Committee meeting with Mexico took place on 17th November in Cancun. Both parties agreed to better focus collaboration on a limited number of key areas of mutual interest with the view of increasing the scale and scope of cooperation. In the area of food, agriculture and biotechnology research, a partnering initiative will be developed on biodiversity in agriculture with Latin American countries. An exchange of letters to formalise this agreement will take place shortly. A workshop on biodiversity will also be organised in spring 2012. In the area of social sciences and humanities research, it was agreed to examine ways of strengthening research cooperation with the principal European social sciences funding organisations, potentially through programme-level collaboration on specific thematic subjects. Finally, cooperation in renewable energy research will be explored with the Joint Research Centre.

# **Australian Chief Scientist in Brussels**

On 23 November the Australian Chief Scientist, Professor Ian Chubb was in Brussels for meetings with DG RTD and with the Cabinet of President Barroso. The meetings underlined the areas of successful R&I cooperation, including health and ICT as well as biotechnology research through the multi partner KBBE Forum initiative. Information was provided on the ongoing review of R&I in Australia, including: potential new tax incentives to facilitate business involvement in research, including for foreign operators; the need for increased sustainability in research areas such as mining; and

governance measures to increase public trust in science.

# Joint EU-Australia Study on supporting the mobility of workers and learners

A study exploring the potential role of qualifications frameworks in supporting the mobility of workers and learners and the possible linkages opportunities between the European Qualifications Framework (EQF) and the Australian Qualifications Framework (AQF) has recently been finalised. The analysis shows that many factors may create an increasing demand for the use of systemic tools for the recognition of qualifications, such as frameworks. These factors include increasing and more diverse workers' and student mobility; stronger linkages between qualifications recognition and immigration rules; and continued growth in the demand for formal and informal recognition of foreign qualifications. The study also shows that there could be significant gains for both Europe and Australia in developing an appropriate relationship between the EQF and AQF, but that this would require solid and transparent quality assurance procedures to improve trust of qualifications frameworks and hence facilitate mutual recognition.

#### **EU-China FAB taskforce**

A meeting of the EU-China task force on food, agriculture and biotechnologies research was held in Beijing on 20 October. Tim Hall, Head of the Agriculture, Forest, Fisheries and Aquaculture Unit in DG RTD, and Gong Xifeng, Deputy Director General of International Cooperation Department in the Chinese Academy of Agricultural Sciences, cochaired the meeting. The meeting discussed cooperation in animal health, management of natural resources and integrated pest management, as well as policy level cooperation (foresight and policy research), food safety and red palm weevil control.

#### **Discussing EU-US S&T cooperation**

The EU-US Joint Consultative Group (JCG) met in Brussels on 3-4 November, to discuss future areas of cooperation under the EU-US S&T Cooperation Agreement. Thematic sessions were held on 3 November, with discussion on energy cooperation under the EU-US Energy Council's Technology Working Group; climate change and land use; critical raw materials; nanotechnologies, water resources management and coastal research; and fostering

greater research cooperation. The outcomes of the JCG meeting emphasised the importance of STI for economic growth and job creation and the possibilities to collaborate on societal challenges and key enabling technologies. It also discussed ways to develop more ambitious, larger scale joint efforts as well as addressing common values shared by US and EU researchers, such as merit review and open access to data.

# Transatlantic study on emerging skills and competences

The results of the first comparative study on institutional and policy approaches to emerging new skills needs in Europe and the US have recently been published. The study shows that although there are considerable variations of both policies and institutional practices on both sides of the Atlantic, common trends can be identified. There is a growing concern on the adequacy of education and training systems to meet the demands of the 21st century workplace which has lead to an emphasis on the development of key competences/21st century skills through outcome and competence based education approaches. As this shift will require changes in the design of teaching and learning processes, the study proposed a series of joint actions in the areas of key development, competence accountability performance, entrepreneurship in education, and anticipation of skills.

## **EU-US** Higher education cooperation

Mobility of students and the development of joint and double degrees have been important features of the EU-US cooperation in education and training. Aimed at identifying elements of good practice which facilitate successful recognition of credits and qualifications gained through this mobility, the European Commission and the US Department of Education commissioned two separate studies that resulted in a single set of conclusions and recommendations. The studies emphasise that higher education institutions and their staff are the key actors in enabling credit recognition and transfer and show that many obstacles related to credit recognition can be overcome with a better understanding of the different systems and by policy makers and stakeholders in the field supporting a trust building process between higher education institutions.

#### Joint Committee with Albania

The second EU-Albania Research Committee took place on 7 November in Tirana. It was noted that over the last year, Albania has organised several FP7 information days and workshops which has led to more FP7 applications. The Committee considered measures on which Albania should focus further cooperation in FP7, including smart specialisation, concentrating efforts on areas of regional interest, such as coastal research, and identifying success stories to stimulate R&I cooperation with EU partners. The meeting was followed by a conference on human capital building, which presented the range of EU actions for the mobility of researchers.

#### First R&I dialogue with Ukraine

The first meeting of the Joint Committee established under the EU-Ukraine S&T Cooperation Agreement took place in Brussels on 23 November. Ukrainian delegation was led by the State Agency for Science, Innovation and Informatisation. Ukraine is currently the 7<sup>th</sup> most active international cooperation partner country in FP7. Both sides reviewed the current levels of cooperation under both FP7 and through Ukrainian funding programmes discussed ways of increasing cooperation notably in areas of health. nanotechnology/materials research, including on a biregional level with the other countries of the Eastern Partnership.

# Discussing synergies between international cooperation projects, programmes and policies

The 5<sup>th</sup> meeting of the International Learning Network held in Brussels on 10-11 November revealed significant opportunities for international cooperation through FP7 ERA-NETs. Coordinators of regional ERA-NETs, funded under the FP7 International Cooperation programme, exchanged experiences with thematic ERA-NETs, INCO-NET projects, Joint Programming Initiatives, and projects funded through Article 185 actions. The common conclusion was that third country funding agencies should be further encouraged to join thematic ERA-NETs, and that the experience gained through the international cooperation regional ERA-NETs should facilitate the creation of such links. At present, only a very few of the thematic ERA-NETs have experience of cooperation with third country partners, but this cooperation has largely been positive. The workshop demonstrated that the international opening of ERANETs represents an opportunity, particularly to address global societal challenges.

# Seminar on doctoral studies in the EU's neighbouring countries and the Western Balkans On 21 October doctoral studies specialists from the EU's neighbourhood countries and the Western Balkans gathered at a seminar in Brussels to discuss the findings of a study, commissioned by DG EAC, which aimed at mapping the organisation of doctoral studies in these countries. Workshops organised around geographical working groups allowed for of views on kev practices exchange developments, and encouraged discussions on how to improve future support of doctoral programmes in the region. A common need for structural reform, a lack of definition of research priorities, increasing research capacity, the issue of quality, accreditation and funding were amongst the challenges identified. The session ended with suggestions for further cooperation between the countries involved and the EU and emphasis was placed on the potential of existing EU tools, such as Tempus, Marie Curie and

Erasmus Mundus, that can be used to address the challenges identified.

# Latin America's new dynamic

A one day policy summit on EU-Latin America relations was organised on 21 November by Friends of Europe in collaboration with the UN Economic Commission for Latin America and the Caribbean and @LIS. The audience participated in interesting and sometimes provocative panel discussions, which eliminated many a stereotype about the region, such as the perception that Latin America would have relations mostly with the Iberian countries. It was underlined that all 'large' and many middle-sized European countries had significant presence and that foreign direct investment from European countries in Latin America was at least twice as large as that in China, India, South Africa and Russia combined. DG RTD Deputy Director-General Rudolf Strohmeier spoke in a panel session on R&I and highlighted the strong mandate from the last EU-LAC Summit to develop cooperation through the Joint Initiative on R&I, engaging also member countries on both sides. He noted that cooperation was increasing, with 100 more current participations from LAC teams in FP7 than in the whole of FP6.

## Global innovation roundtable in India

The EU Delegation in New Delhi attended a Global Innovation Roundtable, organised by the Indian National Innovation Council and chaired by Sam Pitroda (adviser to the Prime Minister of India on innovation), which brought together the heads of innovation from 15 Governments to discuss the role of innovation in improving growth and welfare. India is stressing inclusive innovation for reducing growing disparities in society, but it is also for improving competitiveness by lowering costs, expanding markets and opportunities for businesses. The 'More for Less for Many' strategy calls for more performance products and services, created by using less and less resources and available to (and affordable by) many people. At the time of the roundtable, the Prime Minister of India released a report on Indian innovation strategy. The purpose of the strategy is to encourage, inspire and empower people to think, discover, innovate and implement novel solutions at the local and national level to put India on the path of growth and sustainable development.

# Launch of international initiative on traumatic brain injury

DG RTD, together with the US National Institutes of Health and the Canadian Institutes for Health Research launched the 'International Initiative on Traumatic Brain Injury' (InTBIR) during a dedicated workshop in Brussels in October. Traumatic brain injury affects some 1.2 million new patients each year in the EU alone and is today the main cause of disability in people under 40. The objective of InTBIR is to identify and support evidence-based interventions to improve outcome in traumatic brain injury patients. This will be achieved at the international level through data collection and sharing coupled to comparative effectiveness research. InTBIR is expected to be supported with at least €50 million from EU, Canada and the US. Any other public funding agency can join the initiative which is expected to continue for at least the next 10 years.

#### ERC and neuroscience

Representatives from the ERC attended the annual meeting of the <u>Society for Neuroscience in Washington</u>. The meeting is the world's largest annual gathering of professionals in neuroscience, attracting more than 30,000 scientists and clinicians from more than 150 countries to advance knowledge on functions and dysfunctions of the nervous system. ## Education and science cooperation with Russia

The Russian National Research University 'Higher School of Economics' held a conference on international cooperation in education and science on 25-26 October in Moscow. The event was supported by the FP7 BILAT-RUS project, and the Russian Ministry of Education and Science. Some 70 representatives from funding institutions, research organisations, universities, and industrial entities participated in the conference, which included a specific session on 'Russia-EU Cooperation in Academic Mobility' which focused on overall EU-Russia S&T cooperation and the opportunities available through the FP7 Marie Curie Actions.

#### Galileo into orbit

On 21 October the Russian Soyuz rocket took off from Europe's spaceport in French Guiana to lift into

orbit the first pair of satellites for the Galileo global navigation satellite system. This was the first ever launch of Soyuz from the European Spaceport. This historical event is one of the achievements of a strong EU-Russia space cooperation.

## End of 'Mars' mission

On 4 November the simulated mission to Mars successfully ended after 17 months. Mars500, the first full-length, high-fidelity simulation of a human mission to Mars, started on 3 June 2010, at the Russian Academy of Sciences Institute of Biomedical Problems in Moscow. The international crew of three Russians, two Europeans and one Chinese were isolated in an interplanetary spacecraft mock-up, following the phases of a real mission: a flight to Mars, insertion into orbit around the planet, landing, surface exploration, return to orbit, and return flight and arrival at Earth. During the 'flight', the crew performed more than 100 experiments, all linked to the problems of long-duration missions in deep space. Results shall become available in April 2012.

# **EU- Japan-US trilateral workshop on rare earths**

On the invitation of the European Commission the first trilateral exchange workshop on rare earths was held on 4 October at the European Institute in Washington between the EU (DG RTD), Japan (METI) and US (DoE) to explore strategies on what kind of research collaboration will be necessary to secure, recycle or substitute rare earth materials for new technologies. An EU-Japan call on rare earths is currently being prepared. A bilateral preparatory workshop was held in Tokyo in 20-21 November, while the second trilateral meeting is expected to be held in Japan next spring.
