THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the Regulation (EU) No 508/2014 of the European Parliament and Council of 15 May 2014 on the European Maritime and Fisheries Fund repealing Council Regulation (EC) No 2328/2003, (EC) No 861/2006, (EC) No 1198/2006, (EC) No 791/2007, Regulation No 1255/2011 of the European Parliament and of the Council¹, and in particular Article 23 thereof,

Having regard to the Regulation (EU) No 1380/2013 of the European Parliament and Council of 11 December 2013 on the Common Fisheries Policy, amending Council Regulations (EC) No 1954/2003 and (EC) No 1224/2009 and repealing Council Regulations (EC) No 2371/2002 and (EC) No 639/2004 and Council Decision 2004/585/EC², and in particular Article 45 (3) thereof,

Having regard to the Regulation (EU) No 1379/2013 of the European Parliament and of the Council of 11 December 2013 on the common organisation of the markets in fishery and aquaculture products, amending Council Regulations (EC) No 1184/2006 and (EC) No 1224/2009 and repealing Council Regulation (EC) No 104/2000³, and in particular Article 42 thereof

Having regard to the Commission Decision 2005/629/EC establishing a Scientific, Technical and Economic Committee for Fisheries⁴, in particular Article 9 thereof,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012⁵ and in particular Article 110 thereof,

Whereas:

- (1) In order to ensure implementation of the European Maritime and Fisheries Fund, it is necessary to adopt an annual financing decision, which constitutes the annual work programme for 2019. Article 110 of Regulation (EU, Euratom) No 2018/1046 ("the Financial Regulation") establishes detailed rules on financing decisions.

- (2) It is appropriate to authorise the award of grants without a call for proposals and to provide for the conditions for awarding those grants.
- (3) Under Article 195(d) of the Financial Regulation, grants may be awarded without a call for proposals to bodies identified in a basic act, within the meaning of Article 58 of the Financial Regulation, as beneficiaries of a grant. The following bodies are identified in a basic act as beneficiaries of a grant: Advisory Councils established in accordance with Article 43 of Regulation (EC) No 1380/2013 on the Common Fisheries Policy.
- (4) Under Articles 195(c) and (f) of the Financial Regulation, grants may be awarded without a call for proposals to bodies with a de jure or de facto monopoly or that have a high degree of specialisation, or because of their administrative power. It is appropriate to authorise the award of grants without a call for proposals to bodies identified in the Annex, in accordance with the conditions set out therein.
- (5) It is necessary to allow for the payment of interest due for late payment on the basis of Article 116(5) of Regulation (EU, Euratom) No 2018/1046.
- (6) In order to allow for flexibility in the implementation of the work programme, it is appropriate to allow changes which should not be considered substantial for the purposes of Article 110(5) of the Financial Regulation.
- (7) The measures provided for in this Decision are in accordance with the opinion of the Committee established by Article 127 of Regulation (EU) No 508/2014 on the European Maritime and Fisheries Fund.

HAS DECIDED AS FOLLOWS:

Article 1
The work programme

The annual financing decision constituting the annual work programme for the implementation of the European Maritime and Fisheries Fund for 2019 as set out in the Annex, is adopted.

Article 2
Union contribution

The maximum Union contribution for the implementation of the programme for the year 2019 is set at EUR 87,588,000 and shall be financed from the appropriations entered in the following lines of the general budget of the Union:

- (a) 11 06 61 Integrated Maritime Policy: 49,340,000 EUR
- (b) 11 06 62 01 Scientific advice: 9,300,000 EUR
- (c) 11 06 62 02 Control and enforcement: 5,500,000 EUR
- (d) 11 06 62 03 Voluntary contributions to international organisations 13,640,000 EUR
- (e) 11 06 62 04 Governance and communication 5,900,000 EUR
- (f) 11 06 62 05 Market intelligence 3,908,000 EUR

The appropriations provided for in the first paragraph may also cover interest due for late payment.

The implementation of this Decision is subject to the availability of the appropriations as provided for in the draft general budget of the Union for 2019, following the adoption of that budget by the budget authority or as provided for in the provisional twelfths.

Article 3
Flexibility clause

Cumulated changes to the allocations to specific actions not exceeding 20% of the maximum Union contribution set in the first paragraph of Article 2 of this Decision shall not be considered to be substantial for the purposes of Article 110(5) of the Financial Regulation, where those changes do not significantly affect the nature of the actions and the objective of the work programme.

The authorising officer responsible may apply the changes referred to in the first paragraph.

Those changes shall be applied in accordance with the principles of sound financial management and proportionality.

Article 4
Grants

Grants may be awarded without a call for proposals to the bodies referred to in the Annex in accordance with the conditions set out therein.

1.1. Introduction

1.2. GRANTS

FOSTERING THE DEVELOPMENT AND IMPLEMENTATION OF THE UNION'S INTEGRATED MARITIME POLICY (IMP)

1.2.1.1. Environmental monitoring of ocean energy deployment

Priorities of the year, objectives pursued and expected results	<p>By removing uncertainties over potential environmental impacts, this action will lower risks and costs for future ocean energy deployments and contribute to facilitate the consenting process by Member States' competent authorities. It will benefit the development of the ocean energy sector as a whole.</p> <p>The action should contribute to:</p> <ul style="list-style-type: none">• increase the environmental data and analysis available on the potential impact of wave, tidal and Ocean Thermal Energy Conversion (OTEC) devices;• reduce the uncertainty in modelling potential impacts of future wave, tidal and OTEC devices;• integrate the ocean energy development into Member States' Maritime Spatial Planning;• address public acceptance and consultation. <p>This is the second call for proposals in this area launched with</p>

	support of the EMFF. It shall build on existing experience and knowledge, including from the first call (EASME/EMFF/2017/1.2.1.1). Tests to gather data on impacts of ocean energy devices may take place in non-EU waters but, in that case, their relevance to the development of the sector in the EU must be adequately justified.

Proposals must be submitted by a consortium of minimum two legal entities from two different countries. Priorities of the year, objectives pursued and	<p>The ECGFF is organised each year by a host country agreed by the Member States' participating Coast Guard authorities (the host for 2019 will be Italy).</p> <p>The objective of the action is to support the ECGFF annual high-level</p>

expected results	<p>conference and related planning activities, such as secretariat meetings, in order to enhance sectorial and cross-sectorial cooperation between national authorities performing Coast Guard Functions, exchange of best practices and promote a dialogue at international, regional and national level.</p> <p>The support to the ECGFF is complementary to the European cooperation on coast guard functions based on the revised EU legislation regulating the activities of the three EU maritime Agencies: European Maritime Safety Agency (EMSA), European Fisheries Control Agency (EFCA) and the European Border and Coast Guard Agency (Frontex). This action will enhance cooperation between authorities to manage safety, security, environmental and other coast guard functions and will allow a bottom-up approach within the inter-agency cooperation.</p>

1.2.1.3. Mediterranean Coast Guard Functions Forum (MCGFF)

Priorities of the year, objectives pursued and expected results	<p>International cooperation is a key element to meet the challenges arising from the management of sea basins shared by Member States and third countries.</p> <p>In 2009, a forum was created to bring together the public authorities carrying out coast guard functions in Member States and in third countries bordering the Mediterranean Sea. Since then, annual sessions of this forum have taken place. The host nation for 2019 will be France co-chairing together with Morocco.</p> <p>The main objective of this grant is to support the MCGFF framework of cooperation, in order to enable national authorities in charge of coast guard functions across the Mediterranean basin to develop mutual knowledge, share experience and best practices, as well as to identify areas for further cooperation.</p>
Essential eligibility,	The grant will be awarded to the public body indicated for the

selection and award criteria	<p>organisation by the MCGFF host country's relevant authorities in accordance with Article 195(f) of the Financial Regulation.</p> <p>The applicant should demonstrate that the organisation and management structure proposed for the project are sufficient to achieve the required quality and the deployment of resources in relation to the objectives is cost effective.</p>
Implementation	The action will be implemented by EASME.
Cofinancing involved	Maximum 80%
Indicative timetable	Grant agreement to be concluded in the second quarter of 2019.

1.2.1.4. Knowledge management for the blue economy in the Black Sea

Type	Action grant without a call for proposals
Budget	€ 100.000
Priorities of the year, objectives pursued and expected results	<p>As part of the deliverables of the Facility for Blue Growth assistance project and the Ministerial Declaration Towards a Common Maritime Agenda for the Black Sea adopted in Burgas on 31 May 2018, the identification, mapping and promotion of projects on the blue economy and Integrated Maritime Policy (IMP) in the Black Sea should be further developed.</p> <p>This will be done on the basis of knowledge about the blue economy gathered in a Virtual Knowledge Centre (VKC) on marine and maritime affairs in the Black Sea, started by the Facility for Blue Growth assistance project (Contract notice ref. 2017/S 076-146539 under call EASME/EMFF/2017/003 of action 1.3.1.8 of work programme 2017). The VKC consolidates and shares available information and data in order to improve synergies in the Black Sea between the different existing initiatives, projects and data on marine and maritime affairs.</p> <p>The main objective of the grant is to support the blue economy and innovation in the region by enabling the Black Sea Economic Cooperation (BSEC) Secretariat to manage the VKC and support research work for the constant updating and improvement of its content. For example, the mapping of existing financing opportunities for IMP-related projects at national and regional level, country details on IMP and blue economy issues, mapping of co-operation networks such as maritime clusters, identification and promotion of innovative emerging technologies.</p>
Award criteria	<p>The grant will be awarded to the BSEC according to Article 195(f) of the Financial Regulation.</p> <p>The applicant should demonstrate that the organisation and management structure proposed for the project are sufficient to achieve the required quality and the deployment of resources in relation to the objectives is cost effective.</p>

1.2.1.5. Support to awareness raising about the Saami

Type	Action grant without a call for proposals
Budget	€ 80.000
Priorities of the year, objectives pursued and expected results	<p>The EU's Arctic policy emphasises the importance of engaging with Arctic indigenous peoples and local communities to ensure that their views and rights are respected and promoted in the ongoing development of EU policies affecting the Arctic, including the EU's maritime and fisheries policies. The Saami people are the indigenous peoples living in the European Arctic. Their homeland (Sápmi) extends across parts of Finland, Sweden, Norway and Russia. For centuries, alongside reindeer husbandry, the Saami have been fishing along the coasts, lakes, and rivers and have been using the coastline and major rivers as their trade routes.</p> <p>The objective of this action is to promote dialogue and cooperation with the Saami people in order to foster a more integrated maritime and coastal governance. Specifically, the action will aim to increase the visibility and raise awareness of the challenges facing the Saami as a result of the rapidly changing Arctic environment and to enable policy makers to take into account Saami perspectives regarding marine and coastal affairs. To this end, the action is expected to:</p> <ul style="list-style-type: none"> • make available information about the Saami and their way of life; • present Saami perspectives and experiences, in particular on issues and policies of interest to them or affecting them; • increase awareness of Saami rights, traditional livelihoods (e.g. fisheries, right to use of water resources), knowledge, culture and language; • promote dialogue, cooperation and exchange of information and best practices with other relevant stakeholders (including other indigenous peoples and communities), particularly on maritime and marine issues. <p>This action will complement the annual Arctic Indigenous Peoples Dialogue organised by the Commission. Within the holistic approach which characterises the EU's Arctic policy, this action may also cover traditional land-based Saami livelihoods and related issues.</p>

The applicant should demonstrate that the organisation and management structure proposed for the implementation of the actions are sufficient to achieve the required quality and the deployment of resources in relation to the objectives is cost effective.

Priorities of the year, objectives pursued and expected results	The grant will support the following tasks to be carried out by the Union for the Mediterranean (UfM) Secretariat: <ul style="list-style-type: none"> • the regional dialogue on integrated maritime policy; • the take over of the implementation of specific actions, projects and initiatives, such as the further development of the Virtual Knowledge Centre on marine and maritime affairs and the implementation of the Initiative for the Sustainable Development of the Blue Economy in the Western Mediterranean; • the identification and promotion of projects, in line with the relevant regional priorities, in the field of the blue economy; • the organisation of events within the framework of the UfM Blue Economy Forum, such as meetings of the UfM Blue Economy Working Group, regional seminars and conferences.
Essential eligibility, selection and award criteria	The grant will be awarded to the UfM Secretariat according to Article 195(f) of the Financial Regulation. The applicant should demonstrate that the organisation and management structure proposed for the project are sufficient to achieve the required quality and the deployment of resources in relation to the objectives is cost effective.

1.2.1.7. Setting up and enabling the transition phase to CISE operations

Budget	€ 3.500.000
Priorities of the year, objectives pursued and expected results	<p>The Common Information Sharing Environment for the maritime domain (CISE) initiative aims to better interconnect authorities active in maritime surveillance. In order to improve the authorities' capacities for their missions at sea, there is a need to develop an increased interoperability between existing national surveillance systems and networks and to support an enhanced exchange of relevant information and data across sectors and borders.</p> <p>The present action aims at engaging the European Maritime Safety Agency (EMSA) in further developing the integration and interoperability between three layers of information exchange across the EU:</p> <ul style="list-style-type: none"> • the mandatory exchanges amongst EU Agencies in the framework of coast guard cooperation (Layer 1); • the mandatory and voluntary data exchanges between Member States' authorities and EU Agencies (Layer 2) and; • the exchanges within or amongst Member States' authorities (Layer 3 –CISE initiative). <p>The first objective of the action is to support efforts in the Member States and EEA countries committed to implementing the CISE interoperability building blocks (developed and tested in the EUCISE 2020 project), in order for them to become operational and self-sustaining, within the CISE context by 2020. The action therefore builds on the network of Member State authorities developed for testing purposes within the EUCISE 2020 project. It seeks to produce concrete results that will allow for further effective information exchange between the EU and national authorities within the CISE context. Furthermore, it will allow Member States' authorities to complete the adaptation of their systems (for the authorities involved in EUCISE 2020) and will facilitate, for the ones not involved in EU CISE 2020 but committed to CISE, taking up the tested solutions and implementing them in their systems (layer 3).</p> <p>The second aim of the action is to ensure coherent evolution from EUCISE 2020 pre-operational validation status to CISE day-to-day operations by setting up the technical, operational and administrative framework allowing for the management and coordination of the transition to future governance of day-to-day operations of the CISE network and interoperability solutions developed under the EU CISE 2020 project.</p> <p>The third objective is to undertake the necessary steps to connect and align layers 2 and 3 and to test the data exchange between those two layers.</p>
Essential eligibility, selection and award criteria	<p>The grant will be awarded to EMSA according to Article 195(f) of the Financial Regulation.</p> <p>The applicant should demonstrate that:</p> <ul style="list-style-type: none"> • the organisation and management structure proposed for the implementation of the tasks are sufficient to achieve the required

	<p>quality and a timely transition to a sustainable CISE;</p> <ul style="list-style-type: none"> • the deployment of resources in relation to the objectives is cost effective; • the assistance provided to Member States and Member State authorities is strictly necessary to transfer the interoperability solutions developed under the EU-funded CISE 2020 project into sustainable operational activities. <p>The Commission may require that assistance to Member States authorities is verified to be complementary to previous and on-going EU funding.</p>

1.2.1.8. Maritime Spatial Planning (MSP) projects

Type	Action grant following a call for proposals
Budget	€ 3.000.000
Priorities of the year, objectives pursued and expected results	<p>The objective of these grants is to support the implementation of the MSP including through the Directive 2014/89 establishing a framework for MSP. This will be particularly important in view of the fact that Member States will need to set up their MSP processes if they are to meet the Directive's deadline for the establishment and implementation of their maritime spatial plans by 2021, at the latest.</p> <p>The grants will support cross-border MSP cooperation initiatives between Member States, in principle, in the Mediterranean.</p> <p>The projects will involve concrete actions in Member States helping to build capacity for the implementation of the Directive and will provide support for the establishment of lasting mechanisms for cross-border cooperation. They will build on prior experience from existing and past MSP projects. Support to third countries may be included where cross-border MSP cooperation requires third country involvement in the given sea basin.</p>
Award criteria	<p>Eligibility criteria:</p> <p>Applicants must be public authorities or bodies in charge of maritime spatial planning of those coastal Member States which are responsible for MSP in the selected area. The coordinating entity must be established in an EU Member State.</p> <p>Other legal entities shall be considered eligible applicants provided that they are endorsed by the public authorities or bodies in charge of maritime spatial planning at national level in the related coastal Member States.</p> <p>Applicants from at least two Member States must be involved in each proposal, except for proposals concerning the Outermost Regions.</p>

	<p>If a project activity to be carried out in the waters of the EU or an EU Outermost Region also extends into neighbouring waters outside the territory of the Union, applicants established in the non-EU countries in whose jurisdiction these waters fall, are eligible, providing that the involvement of those applicants is necessary in view of the nature of the action and in order to achieve its objectives.</p> <p>Selection criteria:</p> <p>Applicants must have the financial and operational capacity required to implement and complete the proposed project.</p> <p>Award criteria:</p> <ul style="list-style-type: none"> • Relevance and added value: Relevance of the proposal and its expected results to achieving the objectives of the action. Added value of the proposal in terms of innovation, synergies/complementarity with other relevant initiatives or EU policies, capacity to involve and promote dialogue and cooperation with relevant stakeholders, coverage of Member States bordering the selected area. • Project implementation: effectiveness and coherence of the work plan. Feasibility in terms of activities and timetable. Appropriate and balanced allocation of tasks and human resources. Appropriate project management set-up. Complementarity of partners. Adequate risk management. Cost-effectiveness of the proposal. • Expected outputs and impacts: Dissemination, sustainability and transferability of the expected results, potential multiplier effect. <p>The action aims at supporting at least one project in each of the targeted sea basins covered by the action, provided that for each sub-sea basin at least one proposal reaches a sufficient quality score following the evaluation of the award criteria.</p>

1.2.1.9. Blue economy window

Type	Action grant following a call for proposals
Budget	€ 22.855.000
Priorities of the year, objectives pursued and expected results	<p>The aim is to bring to market new products, services and business models in blue economy value chains and sustainable blue growth in Europe's sea basins.</p> <p>The Commission's first economic report on the blue economy shows that innovative and emerging maritime sectors such as the maritime bio-economy and other sustainably managed and/or innovative sectors have a growth potential that can out-perform traditional</p>

	<p>sectors and create new opportunities and maritime jobs.</p> <p>However, a market study conducted by the Commission shows that there is a lack of investment in blue growth SMEs. The study concludes that both more EU investment support is needed in this area and that private investors need to be encouraged to give more attention to such emerging maritime businesses. In particular, the market study shows that businesses in innovative and sustainable blue economy sectors, while receiving good financial support including from Horizon 2020 at the research stage, lack support on the path towards market entry and scaling up.</p> <p>The objective therefore is to develop and bring to market new products, services and business models that could drive economic growth with a view to develop pre-commercial innovations into ultimately revenue-generating activity. This will involve in particular the sustainable use of marine resources for economic growth, improved livelihoods and jobs, whilst contributing to EU goals.</p> <p>EU goals include in particular a sustainable blue economy, especially in Europe's sea basins, energy and food security, circular economy, reduced carbon and environmental footprint and competitiveness on a global scale.</p> <p>The grants shall aim to develop business concepts further into a market-ready product, service or process aligned with the applicant's blue economy growth strategy. Activities could, for example, include trials, prototyping, validation, demonstration and testing in real-world conditions, and market replication.</p>
