Call for proposals: UNDERSTANDING EUROPE - PROMOTING THE EUROPEAN PUBLIC AND CULTURAL SPACE (H2020-SC6- CULT-COOP-2016-2017)

Budget per topic with separate 'call-budget-split':

- Budget Split 1 (CULT-COOP-01-02-03-04-05-06-07-12)- RIA: EUR 27,5 million
- Budget Split 2 (CULT-COOP-09)- RIA: EUR 9 million

The Agency has now completed the evaluation of the proposals submitted to the above-mentioned call.

In accordance with [General Annex H of the Main Work Programme](#), the evaluation of the first-stage proposals was made looking only at the criteria 'excellence' and 'impact'. The threshold for both criteria was 4. The overall threshold (applying to the sum of the two individual scores) was set for each topic/type of action with separate call-budget-split at a level that allowed the total requested budget of proposals admitted to stage 2 be as close as possible to 3 times the available budget (and not below 2.5 times the budget):

Total budget requested for above-threshold proposals: 129.185.480, 00€ Budget Split 1 (CULT-COOP-01-02-03-04-05-06-07-12) and 36.199.125, 00€ Budget Split 2 (CULT-COOP-09)
