ABSTRACT:

Objectives

FAIR aims to prevent violent radicalization of detainees, promote their disengagement and facilitate reintegration into society. It attempts to create an alert system in prisons to detect early radicalisation signs and to design a model of alternative detention for radicalised detainees

Activities

- project management

ABSTRACT:

The influx of migrant groups in Cyprus from conflict stricken neighboring countries, where radicalization, terrorism and fundamentalism are rising, call for preventive actions against such phenomena. This project is grounded on the European Agenda on Security and the Conclusions of the Council of the EU on enhancing the criminal justice response to radicalization (2015). Even though at present, radicalization appears to be marginal in Cyprus Prisons, by responding to detainee's needs the ELMIP project aspires to be a barrier to radicalism growth in Cyprus and Europe.

The project aims to empower detainees and prison staff through innovative educational opportunities and specialized training. A training curriculum will be composed for educating 40 young detainees 16-35 years old on basic & soft skills through 20 empowering workshops. Prison staff (correctional officers, guards, management staff etc) training will include risk assessment methods targeting overall 200 participants via 9 training & 2 awareness raising workshops.

A dissemination strategy aiming to transform public attitudes towards prisoners' re-entry into society will be devised by organizing awareness activities: 3 Community events, 1 Press conference, 1 Final conference, 5 short video clips of testimonies, a social media campaign and a website. Finally, horizontal activities aim to achieve Management & Coordination through 3 Bilateral Agreements, 1 Management Plan, 6 Progress Reports, 5 Partners Meetings, 1 Steering & 1 Quality Assurance Committees, 2 Official reports & 1 Quality Assurance plan.

Monitoring & Evaluation will be achieved through external project evaluation & an ethics officer.

Outputs include: 180 CAPI assisted interviews and 3 Evaluation workshops Reports (Baseline, Midterm, Final). The expected results reflect the objectives set by the Call by developing appropriate material and implementing activities aiming at detecting early signs of radicalization in prison and reducing recidivism.

ABSTRACT:

The project aims will evaluate the strategies and programmes which prevent, deter and counter radicalization in prison including detention centres. This will identify and analyse good practices regarding new or existing de-radicalization, disengagement and rehabilitation programmes and risk assessment tools. European guidelines will be maintained with the protection of detainees' rights from pre-detention, rehabilitation and probation. Considerations ensured for differing needs based on gender, youth and non-discrimination and utilizing networks to propose improvements.

Research incorporates qualitative and quantitative data analysis on official government documents and with 15 key stakeholders from prison administration and management, prison staff, Imams, chaplains and other religious representatives.

Undertaken by the European Prison Observatory which comprises of the applicant and seven partners in Italy, Portugal, Spain, Latvia, Austria, Germany and Greece. A subcontracted charity will undertake research and attend meetings for the UK.

Groups benefiting include academics, professionals and experts, NGOs, prison staff, probation staff and national policy makers of up to 700 people.

The relevance of results is to develop practices across Europe to effectively manage individuals considered radicalized, at risk of being or to prevent others. Ensuring common knowledge by disseminating to national and European networks will improve de-radicalization measures across prisons.

Outputs are eight national and one comparative report on prison de-radicalization strategies and programmes, also eight updated national reports on prison conditions. Additionally, eight national reports on good prison de-radicalization practices including risk assessment tools and one comparative report including European guidelines will be composed. In total fourteen national public conferences (two per partner country) will be held to exchange and propose practice and policy improvements.

ABSTRACT:

The general objective is to contribute to prevent radicalisation through de-radicalisation, disengagement and rehabilitation programmes in release and probation, notably through multi-agency partnerships that include local authorities.

Specific objectives:

- to develop a state of the art of multi-agency de-radicalisation, disengagement and rehabilitation programmes in release and probation that involve local authorities.
- to identify the needs in this field in order to draw up tailor-made recommendations on the development of multi-agency initiatives in release and probation.
- to strengthen local authorities' capacities on multi-agency tertiary prevention of radicalisation in release and probation.

- to bring together European local authorities willing to address radicalisation through release and probation

ABSTRACT:

ABSTRACT:

This project has 2 objectives:

- Training European judiciary in using a violence extremism risk assessment tool (VERA-2R), in combination with implementation measures: An empirical based violence extremism risk assessment tool will help management and staff in European criminal justice agencies to identify and re-evaluate individuals of (potential) violent extremists and terrorists. Training and implementation will improve use and usability of the tool in the different judicial contexts.
- Development European database violent extremists and jihadist terrorists and their extremist acts: Every European Member State (MS) has too few cases of violent extremists. A European database on violent extremists and terrorists will allow analyses and understanding of extremist risks and drivers, and will help improve strategy and policy interventions across MS.

ABSTRACT:

The criminal justice training to fight against violent radicalisation

COUNTERADHUB is a 16 month project aimed at, firstly, putting in place a national training programme for all professionals related to criminal justice dealing with radicalised violent extremists or those at risk of becoming radicalised in a holistic, multi-disciplinary, multiprofile and sustainable approach, And secondly, devising a multiagency HUB to foster multiagency cooperation within the criminal justice system.

For those objectives, the project analyses criminal Justice instruments to cope with violent extremism and degree of implementation, the needs of training among criminal justice professionals in Spain and the strategy to cope with violent radicalization in the criminal justice system and policy recommendations. Based on that reports, COUNTERADHUB will design the training, implement 3 pilot seminars and set the basis for online training.

All of these work will based on qualitative and quantitative methodologies, mainly, in-dept interviews and focus groups, and surveys among professionals.

The “pilot” training is aimed at 60 professionals split in multiprofile groups in three training sessions: (a) prison management b) prison staff, c) police, d) prosecutors, e) judiciary, f) lawyers g) counselors. At the end of the project a fine-tuned training format will be ready to be delivered to all the professional community around 1500 professionals.

As a result, criminal justice professionals will have an increased knowledge on Countering Violent Extremism and raised awareness on the convenience to be regularly trained and updated. They will also strengthen cooperation among relevant actors to push for an inter-agency approach. The project will foster exchange and participation with existing EU structures to support Member States, will

increase consideration on the contents of the European Agenda on Security and consolidate bridges between iMinisteries and Academy.

ABSTRACT:

To address radicalism and terrorism issues, 3CToD aims to develop evaluation methods and care programs fitting the needs of European correctional and community services.

Based on the program « Cercle sur l'Emprise », created and set up by ARCA toward radicalized inmates in France for one year, 3CToD will lead a risk evaluation and prevention plan for inmates and offenders on probation exposed to radicalism influences. The 3 professional circles correspond to restorative and educational styles, rehabilitation methods and evaluation.

3CToD will be carried out in Belgium, Italy and France, and supported by each national correctional / criminal administrations. University research teams will supervise the translation of training material and manuals, the evaluation of the program and its effects, and the ensuing revision of material and manuals. ARCA will train members of the partner teams to the program; the local team will train professionals from the experiment field (N=60 a minima).

For each country, the program will be applied in at least 2 detention / correctional centers, on adults inmates and offenders (experimental and control groups; N=120 a minima). Data collection and analysis will focus on: the intern coherency of criteria and the fidelity of the evaluation tools; the program experiencing by professionals (qualitative data); the program impact on offenders (qualitative and quantitative data).

3CToD will integrate criminological models of desisting into correctional practices in respect toward the European Probation Rules, and will ensure harmonization. It will provide insights into the

changes in risk and protection factors and desisting in offenders, and into the skills development and self-efficiency perception in professionals regarding the desisting process from radicalism.

Outputs will consist of training meetings (8), training material packages (3 languages), manuals (3 languages), articles (2), a book, a multilingual website, a european congress.
