Summary of the action

The social and economic crisis in Europe and the long term objectives for microenterprise development and for reducing poverty, make microfinance a key tool for the future. Microfinance refers to the provision of financial services to financially and socially excluded people. It includes micro credit defined as a loan of less than €25 000 with no collateral, aimed at supporting the development and/or creation of microenterprises. The European Union has understood the potential of microfinance in relation to the Social Investment Package for Growth and Cohesion and the implementation of the Europe 2020 agenda, and has started to translate this recognition into crucial financial and regulatory initiatives.

Nevertheless, coverage of microfinance in Europe is patchy and provided by institutions very diverse and mostly very small. The European Microfinance Network (EMN), created in 2003 and representing 93 members from 21 countries (by December 2012) will focus its activities in providing common ground and coordination, and push for national-level favourable regulation as well as for enhanced funding for microfinance institutions.

In that context the action aims at strengthening the whole sector in order to give the opportunity to a growing number of European citizens to get access to adequate financial instruments in order to create, develop and sustain their economic activities or to better respond to shocks in the future. By making EMN a strong network with members involved in its activities, with a higher visibility, with a better understanding of the potential of microfinance for create new business and employment (especially for the youth, women, senior, migrants and ethnic minorities) and by supporting the crucial EU initiatives for microfinance, it is expected that the action will succeed in reducing poverty and increasing social, and financial inclusion.

CE's members are supported and empowered allowing them to use their expertise to make a difference at the European and National level. The capacity building actions foreseen are based on an ongoing learning cycle: learning paths on organisational development and advocacy have been designed and will be delivered; a mapping system to know about the key activities of MOs have been developed and national poverty research observatories will be supported; accompaniment of MOs will be ensured, training on accessing EU funding will be organised as well as annual fora around a key theme.

Summary of the action

Europe's overall increase in life expectancy and ageing demographic is generating a growing incidence of age-related diseases and demand for health, social and long-term care. In Europe, 80% of this care is provided by family and friends. The contribution of these informal carers clearly constitutes a great resource for our society but their role is not always recognised as it should. Delivering a wide range of support services such as personal care, housekeeping, transportation, care and financial management as well as emotional support, carers often offer the most comprehensive and desirable option for people in need of care.

Caring for a loved one can be a source of great personal satisfaction but it does create its own set of challenges. These can include physical and mental health problems, a feeling of isolation, difficulty in balancing paid work with care responsibilities, perhaps even financial worries as social provisions are cut back. Advances in medicine also mean that carers find themselves having to deliver more and more sophisticated levels of care, with very little training and minimal support. If society expects informal carers to keep providing care, their vital role and contribution must be recognised and their support needs must be addressed.

Our work and activities in 2016 and beyond will aim to contribute to the recognition of carers' contribution and to the development of equitable and sustainable social, health and long-term care systems in Europe.

Social inequalities in health are not only unfair, they also have a huge economic and social cost. Estimates suggest that inequality-related losses to health amount to more than 700,000 deaths per year and 33 million cases of ill health in the EU. These losses account for 20% of the total costs of healthcare and 15% of the total costs of social security benefits. Our action aims to use EU policies, programmes, and instruments to tackle their underlying causes.

Health systems alone cannot reduce health inequalities as these stem from social, economic and environmental factors. Investments in early childhood, education, better employment conditions and inclusive social protection systems can all contribute to health equity. Acting upon the underlying causes of health inequalities makes economic sense as well as contributes to sustainable societies. The Social Investment Package provides a tool to address these issues at EU level and in 2016 we will contribute to its follow up.

We will build alliances with key stakeholders and promote integrated approaches against health and social inequalities. Health systems contribute to delivering the EU's employment priorities. There are important links to be considered with equity in access, discrimination and gender equality in health systems. EuroHealthNet will act as a knowledge broker between health and social protection systems, develop capacity building, facilitate policy learning and make sure public health communities engage with EU priorities. In 2016 we will build on in-country experiences to facilitate exchanges with public authorities to support the implementation of the Country-Specific Recommendations and social investment approaches. This work will be complemented by an interactive conference to stimulate knowledge sharing amongst members at senior level. With EU and national decision makers, we aim to demonstrate that health and social investments are integral parts of the Europe 2020 strategy.

Summary of the action

The European Social Network (ESN)'s programme for 2016 takes account of the EC political priorities on jobs and modernising social protection through the life-course, the themes highlighted by our members in 2013, and carry forward the work started in previous years. In this light, the programme will include two additional meetings of the working groups on ageing and care and disability, a second workshop on youth, continuation of the work on evidence, a seminar on social services workforce and the launch of the report on children's services.

A second workshop on youth will bring together some of the issues raised in the 2015 workshop around joint work between social services, education and employment for young people with complex needs, with a specific focus on young people in the criminal justice.

After 3 years, the project Investing in children's services, improving outcomes is brought to an end with an event at the European Parliament to launch the final report, including 14 country profiles. We will also take the opportunity to meet and discuss future work on child protection, identified by ESN members as a priority in the 2013 members forum.

In line with a fairer and more social economic union, members of the ESN's Reference Group on the European Semester will continue to analyse their national government's reform programmes and EC's country specific recommendations and provide input for our annual report.

Aligned with the modernisation of social protection systems and services, the Secretariat and our external expert Ann Buchanan will work with members, who wish to do so, to implement the 2015 assessment framework in some of their services.

In connection with a renewed focus on jobs, we will organise a seminar on social services' workforce, which will bring together issues around service planning and coordination, new technology for planning and training, joint work between professionals, workforce's role in quality, and mobility.

- 3. To strengthen the internal working of the network as well as our external representation to improve our rigor, integrity and excellence and increase our impact in the above mentioned goals.
- 4. To pool evidence and relevant information for our policy and advocacy work through our membership and partners. The aim is to gather strong evidence-base both on trends and situation of children and their families in Europe, as well as on practice and implementation of policies relevant for children's well-being

Summary of the action

PICUM will monitor and evaluate social progress, developments and policy changes affecting EU objectives in the areas of employment, social affairs and inclusion, in order to implement transnational and multi-level joint actions, in the following priority areas:

- the disproportionate impacts of health inequalities on women, young people and children:
- undeclared work and social dumping in precarious occupations, in-work poverty, and prolonged periods of irregularity and social exclusion;
- well-being of children and young people;
- gender-based violence and discrimination in the justice system;
- policies resulting in extreme forms of social exclusion; and
- homelessness.

Within these priority areas, the 2016 work plan has further specific objectives outlined in D4.

PICUM will support frontline organisations working to address the urgent social protection needs of undocumented migrants in its EU-wide network. PICUM's thematic working groups and task forces will address specific social inclusion challenges affecting undocumented migrants, enabling members to build the evidence base; evaluate laws, policies and practices; stimulate transfer of promising practices; develop recommendations for reform; and coordinate joint actions. The Annual General Assembly and Members' Workshop will further strengthen and build the capacity of PICUM's membership to effectively engage in policy processes and enact social progress.

To advance informed, effective, and non-discriminatory social policies, PICUM will continue to reach out to and work with a wide range of stakeholders and strategic partners to mainstream its concerns within key civil society initiatives and increase impact through multiplying the stakeholders and engaging new constituencies. PICUM will produce high quality, reliable and accessible evidence and recommendations. PICUM will continue to improve its internal processes, and further develop efficiency and efficacy, as well as good governance.

In 2016 EPR will focus on engaging members further in its activities, including building their capacity on EU policy and processes. EPR will map all potentially relevant Commission initiatives in order to well inform members and prioritise future policy work focusing on employment, disability and social inclusion. EPR will deliver training and services to its members on key EU policy issues to increase their capacity to inform and influence policymaking, as well as on relevant EU funding opportunities. EPR will assist members to develop and pilot innovative services in response to policy priorities, with a view to improving the efficiency and effectiveness of social protection systems. The 2016 comparative analysis on empowerment will include good practice examples and evidence-based policy recommendations. The European benchmarking and benchlearning events (section C.6) will facilitate peer learning and highlight and help Member States disseminate good practices.

To support synergies between stakeholders the secretariat will enhance its structural collaboration with the members of Social Services Europe, particularly in the field of employment and the European Semester. EPR will develop new partnerships with other organisations such as Mental Health Europe, Autism Europe and ENSIE. EPR will continue to run four 'thematic stakeholder committees' and the annual public affairs event. At national level, EPR members will organise a series of multi-stakeholder awareness-raising events and focus groups on specific themes in 4 countries. One event will be in a country not yet covered by EPR.

The annual conference is key to strengthening the internal capacity of EPR and in 2016 will address the ageing of persons with disabilities. A new membership fee structure is expected to have been agreed, and a recruitment strategy will be implemented, particularly seeking new members in non-covered countries and those providing social care. Summary of the action

- Voice the concerns and expectations of its members by collecting those concerns and expectations including the creation of a hub; and by voicing them through a diverse set of external communications including position papers towards institutional actors
- Provide data /research on developments and priority topics, by providing access to data, producing research on key VP/SI-related topics as well as investing in effective dissemination of sector-relevant research.
