Unemployment insurance (Social Code III)


 Unemployed persons with insurance (benefit duration: 1 year) Basic income support for jobseekers (Social Code II)


 Employable persons in need of assistance (may be working)







2 Management by objectives

Management by objectives aims to...

- > Strengthen local scope of action and responsibility
- Encourage peer learning
- Improve performance
- Establish transparency
- > Focus resources on political objectives



2 Management by objectives

Objectives have to be...

- > Specific
- ➤ Measurable
- **Attainable**
- Realistic
- > Timed



2 Management by objectives Unemployment insurance

Unemployment insurance (Social Code III)

- Framework agreement on objectives between Federal Ministry and Federal Employment Agency (§ 1 (3))
 - Objective (among others): Prevent long-term unemployment




Basic income support for jobseekers (Social Code II)

- General objectives of the law (§ 1):
 - Enable benefit recipients to live in human dignity,
 - Assist in finding employment, strengthen individual responsibility,
 - Preserve, improve or regain employability,
 - Provide means of subsistence,
 - Reduce extent & duration of dependence,
 - Ensure gender equality.
- Agreements on objectives (§ 48b)




Agreements on objectives between all involved parties






A common set of objectives, a common data base



Comparison between regions

15 region types

- Statistical clusters with similar characteristics
- To compare ambition of targets
- To compare performance indicators





The annual decentralized planning process

- Agreement on Common Planning Principles (August)
- Submission of Jobcenter target offers (November)
- 3. Negotiation of submitted targets (November to April)
- 4. Conclusion of target agreement (April)
- Realisation of target achievement dialogues (2 per year)
 - Performance indicators are made public, budget is **not** linked to performance indicators



3 LONG-TERM UNEMPLOYMENT

Do the existing performance targets provide incentives to reduce long-term unemployment?



3 Long-term unemployment Do targets set the right incentives?

Contradictory objectives for public employment services

- Rapid integration
- Integration into sustainable jobs
- Integration into vocational education and training measures
- Reducing poverty / reducing long-term unemployment
- Reducing risk for children of growing up in poor households
- Minimizing costs



3 Long-term unemployment Do targets set the right incentives?

Basic income support for jobseekers (Social Code II)

- Agreements on objectives include targets to reduce long-term receipt but **not** long-term unemployment
 - Prevent "revolving door effect" and integrations into low-paid or unsustainable employment
- Potential "false incentives":
 - Creaming: short term unemployed clients are easier to integrate
 - Singles are easier to bring out of welfare dependence than (large) families with children

Objective

Reduction of the need for benefits

- Amount of housing and heating benefits
- Employable persons entitled to benefits
- > Entry rate of employable persons
- Exit rate of employable persons

Improvement of labour market integration

- Rate of entry into marginal employment
- Rate of entry into publicly funded empl.
- Sustainability of integration
- ➤ Integration rate of single parents

Prevention of long-term receipt of benefits

- Integration rate of long-term recipients
- Activation rate of long-term recipients
- Average entry rate of long-term recipients
- Average exit rate of long-term recipients
