

## **SOCIAL ECONOMY:** COUNCIL RECOMMENDATION

The **social economy** prioritises **people, social and environmental causes** over profit. It plays a key role in social innovation, inclusion and job creation, providing bottom-up solutions for key challenges.

Social economy entities can face **difficulties developing and scaling up their activities** because they are not sufficiently understood and recognised. They need more and better support to have an even bigger impact. The Council Recommendation will make it easier for social economy entities to **start up, scale up and be recognised**. more than **13 million** paid jobs

**2.8 million** social economy entities in Europe The social economy encompasses many different sectors, requiring a **whole-of-government approach**. The proposed Council Recommendation sets out **comprehensive, coherent, and up-to-date recommendations** to Member States on how to promote the social economy across policy fields and legal frameworks.

The Commission invites Member States to **design and implement targeted and comprehensive social economy strategies** to create an enabling environment for the social economy to thrive, by looking at different policy areas.

## What are some of the recommendations?



facilitate more **mentoring**, and collaboration between social economy entities and the wider business community



put in place **mechanisms for** consultation and dialogue between the public authorities and organisations representing the social economy



create **apprenticeship schemes** in social economy that support young people, as well as tailored career guidance and training opportunities



set up national competence centres for training on the social economy



create social innovation hubs to harness the social economy potential



acknowledge the **role of the social economy** in providing accessible and high-guality social and care services and housing, particularly for disadvantaged groups



encourage contracting authorities to **purchase** goods and services strategically and to pursue social impact and innovation



ensure that social economy entities have access to **financing** at the right stage of their development and tailored to their needs



make full use of the scope under **State aid rules** to support the social economy



assess whether **tax** systems sufficiently encourage its development and consider tax incentives

**EU funding** is available for the social economy under the ESF+, ERDF and InvestEU and other funding programmes.
