A draft agenda is attached. The final agenda of the meeting and the supporting documents will be uploaded on Yammer before the meeting.



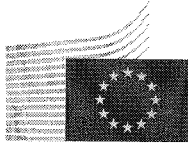
