**SUMMARY OF THE 2<sup>ND</sup> MEETING OF THE EXPERT GROUP FOR AGRICULTURAL  
 MARKETS CONCERNING ASPECT FALLING UNDER THE SCMO REGULATION  
 19 APRIL 2012**

**Draft Commission Delegated Regulation supplementing Council Regulation (EC)  
 No 1234/2007 as regards transnational cooperation and contractual negotiations of  
 producer organisations in the milk and milk products sector (Milk Package<sup>1</sup>).**

The Commission representative presented and explained the changes in the draft Commission Delegated Regulation following remarks from the experts expressed at and after the previous meeting and comments from other Commission services. The document had been sent to the participants (including the EP) prior to the meeting.

In the exchange of views the Commission answered the questions received from the experts of the Member States and took due note of all the comments made. Furthermore, the Commission representative illustrated the calculation of the maximum negotiation volumes by means of some examples given in a working document.

The chair concluded that good progress had been made and, if need be, a modified text of the Draft Regulation could be circulated to the experts. It was not yet clear whether there would be a need for another meeting of the expert group on this subject.
