The Passenger Ship Safety working group meets 4 times a year. The cooperation group of National competent authorities on places of refuge will meet once a year.

Selection Procedure (members)

The members of the group are the Member States. It is for the authority of each of Member State to decide on who will represent them. The EEA/EFTA countries are also invited at the meetings.

Expert groups usually operate in an informal setting without any formal rules of procedure. This is the case for this group.
