## Activity Report

The Working Group on Fertilisers met three times in 2011. Discussions took place on: • A draft legislative proposal to include liming materials and a new nitrification inhibitor within the scope of the Fertilisers Regulation. • The outcomes of a fertiliser study which analysed different policy options for the preparation of an impact assessment report that will support the future Regulation. • The creation of four technical working groups to clarify some provisions of the future legislation. • The preparation of a guidance document on mutual recognition of national fertilisers and an overview of the Member States experience on pursuing infringements for manufacturers established in another Member States. Preliminary discussions to improve the guideline document for the compilation of a technical file on application to register new 'EC fertiliser' types.

## Activity Report

The Working Group on Fertilisers met twice in 2010. Discussions took place on: • A draft legislative proposal to include liming materials and 8 new fertiliser types within the scope of the Fertilisers Regulation. • The recommendations of an ex-post evaluation of Regulation (EC) No 2003/2003 that will feed an impact assessment supporting the revision of the Fertilisers Regulation. • A first set of possible policy options for the revision of the Fertiliser Regulation and its possible extension to organic and organo-mineral fertilisers, soil improvers and growing media. • The current situation in the market surveillance of 'EC Fertilisers' and the issue of the mutual recognition for national fertilisers.
