Activity Report

The group didn't meet in 2011 and a meeting took place on 6th March 2012 : the WGP discussed the alignment of pressure equipment directives to the New Legislative Framework and adopted pressure equipment directive guidelines. A presentation given on the ongoing evaluation of the pressure equipment directive. The next meeting of this group is planned for Q1/2013.

Activity Report

The expert group Working Group Pressure met twice in the course of 2010 in order to endorse guidelines and to support the Commission in the correct implementation of the Directive.

Selection Procedure (members)

The expert group is composed of representatives of the Member States and other stakeholders. The Member States representatives are appointed by their national administrations depending on the agenda of the meeting. Other stakeholders are invited to the meeting as observers if they are representing stakeholders at European level. In the pressure equipment sector, industry is represented by Orgalime, EIGA (European Industrial Gases Association) and AEGPL (European LPG Association). Users are represented by ECUI (European Committee on User Inspectorates).

Expert groups usually operate in an informal setting without any formal rules of procedure. This is the case for this group.
