### **Activity Report**

The last meeting of the group was on 10 March 2011. The main issues in the agenda have been the results of the ex-post evaluation study of the GAD and the revision process of the Directive. The next meeting of the Working Group Gas Appliances will be held in Brussels on 4 June 2012.

### **Activity Report**

The co-ordination of implementation of Directive 2009/142/EC on appliances burning gaseous fuels (GAD) is carried out through the WG-GA, which discusses implementation and interpretation issues of the GAD and meets usually twice per year (last meetings were held in 10/2010 and 03/2011). The main issues in the agenda have been the ex-post evaluation study of the GAD and the revision process of the Directive.

### **Selection Procedure (members)**

The group is composed of representatives of the Member States, European federations, Notified Bodies and CEN and is chaired by a representative of the Commission services. No specific selection procedure has been applied, but all relevant European level Type C organisations active in the gas appliances sector are welcome to participate in the meetings as observers. The decision on whether these organisations send delegates to meetings is made by them independently. Submission of participation form prior to meetings is mandatory.

### **Internal Rules of Procedure**

Expert groups usually operate in an informal setting without any formal rules of procedure. This is the case for this group.
