Selection Procedure (members)

Members of the expert group should be Member States, not individuals. Depending on the agenda, Member States shall decide who to send. On the one hand, a broad knowledge is expected of how public sector electronic identity schemes work is required. In particular experts should have in depth knowledge and experience of working in the majority of the following areas: identity assurance levels, standards relating to the different aspects of electronic identity, governance arrangements and technical and security system requirements. On the other hand expertise on the functioning of the trust services market is necessary element, including all the technical aspects of those services. The experts in person may also be different depending on the respective trust services in stake.

Internal Rules of Procedure

Expert groups usually operate in an informal setting without any formal rules of procedure. This is the case for this group.
