The activities of this group cover also the User Support Network Workshop and the Network ("ESSnet") of Press Officers Meetings held in 2010: 15 & 16 April (Working group), 25 & 26 January 2010 (User Support workshop), June (ESS-net), 25 & 26 October (Working Group) Meetings held in 2011: 14 & 15 February (User Support workshop), 27 May (ESS net), 10 & 11 November Main activities: – to coordinate the development and implementation of European Statistical System (ESS) policy on dissemination and communication; – to discuss and evaluate strategic plans and priorities; – to provide input to the European Statistical System Committee (ESSC); – to ensure that ESSC decisions are implemented. In addition to this role, the group will also operate – as a forum for exchange of knowledge and experience on dissemination and communication; – as the channel for informing National Statistical Institutes (NSIs) about Eurostat's ongoing work and new projects; – as the umbrella group for other groups and networks (user support, ESSnet) and for task forces working on various projects.

### **Selection Procedure (members)**

The members of this group are the Member States, EEA and EFTA countries, candidate countries and potential candidate countries. It is for the authority of each Member State or other country to decide on who will represent them.
