### **Activity Report**

Meetings in 2010: 3-4.3, 11.10. Meeting in 2011: 6-7.10. Activities: The business register (BR) mandate of the working group is to implement the BR Regulation, to harmonise the national statistical business registers, to monitor the quality of the registers, and to establish a register of multinational enterprise groups (MNEs), the EuroGroups register. The group approves the BR and EuroGroups register development programmes and the BR Recommendations Manual. It submits proposals to the European Statistical System Committee for the implementing regulations. The statistical unit (SU) mandate of the group is to define appropriate statistical units used in the production system for the European Statistical System and to standardise the application of the main statistical units: local units, enterprises, and enterprise groups both at resident and global level. The group submits, when necessary, proposal to the European Statistical System Committee for amending the SU Regulation.

### **Selection Procedure (members)**

The members of this group are the Member States. It is for the authority of each country to decide on who will represent them. EFTA countries and candidate countries, OECD, ECB and UNECE are observers.

### **Internal Rules of Procedure**

Expert groups usually operate in an informal setting without any formal rules of procedure. This is the case for this group.
