Activity Report

Main activities: the DMES (Directors' group of MacroEconomic Statistics) has a strategic role in orienting and coordinating the work on national accounts and other macro-economic statistics. It acts as an intermediary between the activities at more technical levels and the European Statistical System Committee. The DMES provides a forum for exchange of views on a range of strategic and management issues related to macro-economic statistics. In particular, the DMES is involved at an early stage in the preparation of the annual and multi-annual programmes by identifying new statistical priorities and possible statistical fields where simplification, reprioritisation and/or phasing-out of certain work could be envisaged.

Selection Procedure (members)

The members of this group are the Member States, EFTA and candidate countries. It is for the authority of each country to decide on who will represent them. ECB (European Central Bank) and OECD (Organisation for Economic Cooperation and Development) are observers.

Internal Rules of Procedure
