Main activities: to report to the Standing Committee of Agricultural Statistics (CPSA) and to implement its decisions; to develop and review the work programme of animal production statistics and to set priorities; to review data and methodology harmonisation on compiling animal production statistics (milk, livestock and meat, poultry and SBS); to comply with the requirements of Regulations (EC) Nos. 1165/2008, 617/2008 and Directive 96/16/EC; to improve and identify new needs regarding the quality of animal production statistics; to manage the various procedures on data delivery based on gentleman's agreements.

### **Selection Procedure (members)**

The members of this group are the Member States, EFTA, candidate and potential candidate countries. It is for the authority of each country to decide on who will represent them.

### **Internal Rules of Procedure**
