Meetings in 2010: Technical Group on Causes of death: 4-5.5 Meetings in 2011: Technical group on European Health Interview Survey (EHIS): 28-29.3; Technical group on Health care statistics: 7-8.4; Technical group on Causes of death statistics: 5-6.5; Working Group Public Health: 28-29.6. Main activities carried out: Steer, ensure development of methodological aspects and legal framework for Public Health statistics, in particular on the domains on Causes of Death (CoD), Health Care, Health Interview Surveys and Morbidity statistics: - Development of Commission regulations implementing Regulation (EC) 1338/2008 on health care data and the European Health Interview Survey (Commission regulation on CoD statistics was adopted on 5 April 2011); - Eurostat data collections and dissemination for CoD, Health care data and European Health Interview Survey (EHIS) plus future diagnosis specific morbidity statistics, including metadata; - Methodological work together with the ESSnet on public health statistics including work on a new short list for CoD and on revising the standard population ; - Data collections and indicators on health from other Eurostat sources, such as SILC (Healthy Life Years indicator) and on disability (LFS ad hoc module on disabled people 2011; European Health and Social Integration Survey 2012); - Cooperation with OECD and WHO especially on the Joint Questionnaire on non-monetary data and on expenditure data, based on the current System of Health Accounts (SHA) manual .1.0 and in view of a revision of that SHA manual.
