Activity Report

Meeting in 2010: 10-11.6. Meeting in 2011: 9-10.6. Main activities: The Business Statistics Directors' Group (BSDG) plays a strategic role in orienting and coordinating the work in the area of business statistics. It is involved at an early stage in the preparation of the annual and multi-annual programmes by presenting the new statistical priorities envisaged and the possible statistical fields where simplification, reprioritisation and/or phasing-out of certain work could be envisaged. The BSDG expresses its opinion on draft legal acts prior to their submission to the ESSC for opinion and their subsequent submission for adoption by the Council and the Parliament or by the Commission. The BSDG should discuss cross-cutting technical issues of high importance. The BSDG expresses its opinion on the launch of statistical surveys on a voluntary basis. The BSDG should monitor and follow up compliance with legal acts in the area of business statistics. The BSDG will provide Member States with a forum for the exchange of best practice in the field of business statistics, by means of a seminar session during BSDG meetings.

Selection Procedure (members)

The members of this group are the Member States, EFTA and candidate countries. It is for the authority of each country to decide on who will represent them. Representative from accession countries are invited as observers.

Internal Rules of Procedure

New Rules of Procedures (RoP) have been adopted at the ESSC meeting in May 2013. Please find the document attached. It has been updated in the BSDG meeting of 24 June 2014. During the ESSC meeting in November 2014, the group has also updated their mandate.
