Selection Procedure (members)

In accordance with Art 13 of Annex XI Staff Regulations the members of this group are 'experts from the appropriate authorities in the MSs'. It is for the authority of each MS to decide on who will represent them. It is important that participants are able to contribute to technical decisions; an active involvement in national price statistics and a general background in spatial or temporal comparisons, household budget statistics, employment law and/or other aspects of expatriate remuneration is therefore desirable. In addition to delegates from MS, participants are invited.

Internal Rules of Procedure

The Art64 Working Group operates under the stipulations of Art 13 of Annex XI Staff Regulations. However, the Group operates without formal rules of procedure, although certain procedures are described in the methodology manuals for the calculation of Intra-EU and Extra-EU correction coefficients, and the memorandum of understanding with UN.ICSC (UN International Civil Service Commission) and the IOS (Inter-Organisation Service of the Coordinated Organisations).
