Experts appointed by Member States' sport departments met regularly from 2008 till 2010 (6 meetings; the last meeting took place on 3 February 2010) in order to monitor the implementation of the 2007 White Paper on Sport and notably the actions included in the "Pierre de Coubertin" Action Plan regarding the societal role of sport, the economic dimension of sport and the organisation of sport. Governmental experts will continue to meet to help the Commission implement new actions contained in the Commission's 2011 Communication on Sport, in particular in the fields of health-enhancing physical activity, social inclusion, education and training in sport, governance issues, and sport statistics. In addition, the Council has adopted a Resolution on a European Union Work Plan for Sport (2011-2014), based on which groups composed of experts appointed by the Member States will help implement a limited number of priority actions with the help of the Commission and as defined by the Council.
