### **Activity Report**

Through the Advisory Board, the Commission ensures involvement and inclusion of stakeholders in the planning for the European Week of Sport that will be organised on 7-13 September 2015. The Advisory Board should be an appropriate format to exchange information and cooperation amongst members. The Advisory Board should give advice and recommendations to the Commission on top line directions of the European Week of Sport.

### **Selection Procedure (members)**

Experts who participate in a composition of this group must have high-level relevant knowledge in a specific area of sport. They may be scientists and academics; this was for instance the case for the expert group which developed the Physical Activity Guidelines. They may also be lawyers and sport governance experts, as was the case for the group of independent sport experts which gave advice on future priorities for the EU's approach to sport. Experts are selected by DG EAC on the basis of a request for nominations addressed to the sport authorities of the Member States, taking due account of their proven expertise and relevant experience in a specific thematic area of sport (incl. a possible role within a sport organisation at national or European level, involvement in sport research, academic record, publications, participation in EU-level discussions)"

### **Internal Rules of Procedure**

Expert groups usually operate in an informal setting without any formal rules of procedure. This is the case for this group.
