(European Commission > CIRCABC > Eurostat > Environment Meetings > Library) Activities: The European Strategy for Environmental Accounting (ESEA), adopted by the SPC in 2003 and revised in 2008, identifies areas of environmental accounting requiring methodological development and effort in terms of data collection. The Working Group discusses the implementation of the ESEA and of the plans for the work in Eurostat on environmental accounts ensuring improved data availability in the core areas and advancements in other important areas. The Working Group focuses in particular on monetary environmental accounting in areas such as environmental protection and resource management expenditure accounts, the environmental goods and services sector (EGSS), environmental taxes and environmental subsidies. A key task of the Working Group is assisting Eurostat in the development and implementation of legal cover for priority areas.
