Meeting held in 2010: Working Group on 'Accidents at work statistics': 27-28.5 Meetings held in 2011: Working Group on 'European Statistics of Accidents at Work '(ESAW) 25-26.5; Working Group on 'occupational diseases' (EODS): 28-29.11 Main activities carried out: For ESAW 2010 and 2011 meeting: ESAW implementing regulation; ESAW data collection understanding, improvement on data and metadata, reviewed dissemination following the NACE Rev.2 introduction, under reporting correction, comparison with the LFS 2007 ad-hoc module; Alignment and knowledge of Commission policies, priorities, related projects or data collections (of Eurostat such as LFS 2007 and 2013 modules but also from other DG or Agencies) and usage; Sharing of good practices in Member States. For EODS 2011 meeting: EODS difficulties in data collections and dissemination; improvement of coverage and metadata; proposals for indicators; Review of the EODS plan for a pragmatic improvement of the quality of EU wide statistics on occupational diseases.
