The Working Group discusses the implementation of the ESEA and of the plans for the work in Eurostat on environmental accounts ensuring improved data availability in the core areas and advancements in other important areas. The Working Group focuses in particular on physical environmental accounting in areas such as air emissions, energy, waste, water and material flow accounts. A key task of the Working Group is assisting Eurostat in the development and implementation of legal cover for priority areas
