It includes developing a common understanding of the requirements in the Regulation and taking decisions to steer the implementation. At the kick-off meeting between the project team and the steering committee, the project team shall present a project description and a project work programme including a timetable. The project description shall explain the understanding of the tasks, the project organisation, the roles and responsibilities and the project method, including the process of consulting and informing all stakeholders. The group has to approve the work programme. Moreover, at the kick-off meeting, the content and level of detail of the intermediate report and of the monthly progress report will be discussed and agreed between the project team and the steering committee. Furthermore, the group has to monitor the work done described in the progress report, analyse and agree on the interim/final deliverables of the project team.

Task: Assist the Commission in the preparation of legislative proposals and policy initiatives

Provides expertise to the Commission when preparing implementing measures, i.e. before the Commission submits these draft measures to a comitology committee
