### **Selection Procedure (members)**

Members of the expert group consist of senior officials of the ministries dealing with energy and the national regulatory authorities of Member States. Each Member State is entitled to appoint 2 permanent and 2 alternate members from the ministry and another 2 permanent and 2 alternate members from the national regulatory authority. Representatives of the European Network of Transmission System Operators in Electricity (ENTSOE) and the Agency for the Cooperation of Energy Regulators (ACER) are also members of the Group.

### **Internal Rules of Procedure**

This Expert Group usually operates in an informal setting without any formal rules of procedure.

### **Other**

The idea of setting up an Electricity Coordination Group was initiated by Member States with a desire to have coordination on a strategic level regarding electricity issues. This wish was explicitly expressed at the informal Energy Council in Wroclaw in September 2011.
