On 5 July 2016, the Commission adopted Decision C(2016) 4098 amending Decision 2012/C 188/02 with regard to the duration of the mandate of the members of the VAT Expert Group, and a call for applications for the selection of members and observers in the VAT Expert group was published. On 29 September 2016, the Director-General for Taxation and Customs Union appointed the members and observers to the VAT Expert Group for a mandate of 3 years starting on 1 October 2016. This is the third mandate of the VAT Expert Group.
