## Activity Report

The Expert Group on Land Transport Security established by Commission Decision 2012/286/EU of 31 May 2012, first meeting in January 2013. The activities aim at developing policy on security relating to land transport, and shall foster ongoing exchanges of relevant experience, policies and practices between the Member States and the various parties involved.

## Selection Procedure (members)

1. Members shall be Member States' competent authorities. They shall nominate two representatives: (a) one representative per Member State from ministries or government departments responsible for land transport; (b) one representative per Member State from ministries or government departments responsible for security or policing issues.
2. The Commission's representatives may give observer status to individuals or invite European representatives of international and professional organisations engaged in, or directly affected by, land transport security as well as transport user organisations.
