For this purpose, they shall meet in a network at regular intervals (approx. 2-3 meetings per year). The first meeting of this network will take place in March 2013.

Selection Procedure (members)

The members of this group are the rail transport regulatory bodies of the Member States. It is for the authority of each Member State to decide on who will represent them. Croatia, as candidate country, and Switzerland, as third country, are invited as observers. Norway is invited as member.

Internal Rules of Procedure

The European Network of Rail Regulatory Bodies adopted its rules of procedures during its second meeting of July 2013.
