The members of the CAF cannot be involved in the following activities: - be charged with assisting the Commission in evaluating proposals and monitoring projects in the implementation of activities in the area of research and technological development - act as advisors or delegates of the or representatives of Member States in the Programme Committees of the European Union

Other

Logistical and operational aspects: The CAF shall meet in Brussels on Commission premises or in another place announced in accordance with the procedures and schedule established by the Commission. The activities of the CAF will be supported by a secretariat put in place by DG CONNECT. Travel and subsistence expenses incurred by participants in the activities of the CAF shall be reimbursed by the Commission in accordance with the provisions in force at the Commission within the limits of the available budgetary appropriations. Participants in the activities of the CAF shall not be remunerated for their duties.
