### Activity Report

The group should meet at least two times a year. The first meeting is scheduled to take place in October 2013. The meetings shall, in principle, be held on Commission premises.

### Selection Procedure (members)

The Advisory group members are selected from the database made with the Call for expressions of interest for the selection of experts for the Horizon 2020 Advisory group. Following criteria is taken into account: Proven competence and experience of the individual candidate or, of the designated representatives from organisations, including at European and/or international level, in area of the challenge. Proven competence and experience of the individual candidate or, of the designated representatives from organisations, in horizontal expertise, including cross-cutting issues of relevance to Horizon 2020. In addition, for individuals appointed to represent a stakeholder interest, the proven capacity of the candidate to represent effectively the position shared by stakeholders, and for individuals appointed to represent an organisation, the competence, experience and hierarchical level of the proposed representative. The final composition of the group takes into account the need to ensure balanced participation in terms of representativeness of stakeholders, gender, age and geographical origin (without calling into question the necessary level of expertise and insight). The experts of the group will be designated in accordance with the Commission rules on expert groups (C(2010) 7649 / SEC(2010) 1360).

### Internal Rules of Procedure

Experts participate in the group in their individual capacity or as individuals representing an interest or an organization. Each expert will serve for a period of two years with the possibility of renewal once for a final period of a maximum two more years; up to half of the members of the group will be replaced every second year. During the first meeting, the group will select the chair. The chair will thereafter change every two years. The group should meet at least two times a year to discuss the general orientations and documents as well as questions put forward by the Commission services. Working groups composed of a sub-set of experts may be created for specific purposes. Each expert will sign a declaration of acceptance covering the confidentiality and conflict of interest issues. Travel and subsistence expenses will be reimbursed according to Commission Decision of 5 December 2007 [C(2007)5858].
