organisations, in horizontal expertise, including cross-cutting issues of relevance to Horizon 2020. In addition, for individuals appointed to represent a stakeholder' interest, the proven capacity of the candidate to represent effectively the position shared by stakeholders, and for individuals appointed to represent a organisation, the competence, experience and hierarchical level of the proposed representative. The final composition of the group takes into account the need to ensure balanced participation in terms of representativeness of stakeholders, gender, age and geographical origin (without calling into question the necessary level of expertise and insight).
