### Selection Procedure (members)

The experts have been selected through a call for expressions of interest is open for the lifetime of the Horizon 2020 programme. Experts can register at any time; expressions of interest will be taken into account for the renewal of groups at the end of each mandate. Experts having expressed their interest by 6 March 2013 are currently being considered for the setting up of the first Horizon 2020 Advisory Groups. Selected experts have been contacted in due course. According to the mandate of the group, each expert will serve for a period of two years with the possibility of renewal once for a final period of maximum two more years; to ensure a regular rotation of experts and fresh input, up to half of the members of the Group will be replaced every second year (the group has been renewed at the beginning of 2016 and will be again at the beginning of 2018).
