**Mission:** The Access to risk finance section under the Industrial Leadership pillar of Horizon 2020 Framework Programme will be based on the same principles as under FP7 but the objectives and the scope of the actions proposed will be much broader and more ambitious. In order to best adapt the proposed new instruments, which will partly be a continuation of the existing ones, to the needs of the market external experts have been asked to provide their opinions and recommendations to Commission proposals. The advice will include a broad range of issues encompassing the design and implementation of debt and equity financial instruments, target groups, SME participation and other cross-cutting issues.

**Task:** Assist the Commission in the preparation of legislative proposals and policy initiatives

Provides expertise to the Commission when preparing implementing measures, i.e. before the Commission submits these draft measures to a comitology committee

### **Selection Procedure (members)**

In view of the creation of Advisory Groups under Horizon 2020 an extensive database containing the names of candidates with experience in various areas and with different profiles was established as a result of a Call for expression of interest published. In addition to that a set of guidelines for the selection of appropriate candidates and for reaching an adequate balance between the proposed experts was outlined. The two documents constituted the basis for the selection of best suited candidates. The first step in the selection process was the identification in the database of those experts who indicated that they had relevant experience and proven competence in 'risk finance'. The pool of 735 individuals was generated. A thorough analysis of the CVs and additional information on the experience and background of all the candidates was carried out. In order to facilitate the work a table comprising all the selection criteria provided for in the "Selection guidelines" was constructed in which the names of all 735 candidates were enlisted. Each of the individuals was assessed against these criteria. This exercise led to the creation of a longlist containing 102 names. Due to the fact that according to the guidelines the number of experts in the Advisory Group should comprise around 20-30 names the shortlisted candidates were again evaluated. At this stage potential combinations of individuals were assessed against the remaining selection criteria provided by the "Selection guidelines" namely: • representativeness of stakeholders; • reaching the gender target of 50%; • balanced geographical distribution; • cross-cutting expertise in research and innovation; • selecting of 50% of newcomers. The final selection respecting all the criteria outlined in the "Selection guidelines" brought 28 candidates with in depth knowledge of risk finance and broad experience in the area were selected out of which 14 are women, 16 have not worked with the European Commission before and the geographical composition of the group is balanced. The names not selected for the primary composition of the Risk Finance Advisory Group were put on the reserve list.

### **Internal Rules of Procedure**

Expert groups usually operate in an informal setting without any formal rules of procedure. This is the case for this group.
