### **Activity Report**

This expert group is dealing with horizontal issues of endocrine disruptors and with the implementation of the Community Strategy on Endocrine Disruptors. The members of this group have met on: - 19 May 2011 (2nd Ad-hoc meeting on Endocrine Disruptors) - 16 November 2011 (3rd Ad-hoc meeting on Endocrine Disruptors) - 29 May 2012 (4th Ad-hoc meeting on Endocrine Disruptors) - 30 November 2012 (5th Ad-hoc meeting on Endocrine Disruptors) - 20 February 2013 (6th Ad-hoc meeting on Endocrine Disruptors) - 30 May 2013 (7th Ad-hoc meeting on Endocrine Disruptors) All the documents have been published and can be consulted at the following link:

### **Selection Procedure (members)**

The members of the group were chosen from the European Commission, relevant European Agencies and the relevant Competent Authorities of the Member States. Commission Services and European Agencies having stakes in the risk assessment and risk management of chemicals were invited to nominate representatives. Member States' Competent Authorities for REACH and CLP, the Standing Committee on the food chain and Member States' Competent Authorities for biocidal products were invited to nominate up to three experts per Member State/EEA EFTA countries. The observers were chosen amongst the representatives of civil society and industry associations, operating at the EU level. Representatives of civil society and of industry associations operating at the EU level, having stakes in three pieces of legislation containing provisions on endocrine disruptors (REACH, Plant Protection Product Regulation, Biocidal Product Regulation), were both invited to nominate up to 4 representatives each as observers to the meeting. The decision on who exactly will participate was left to the respective invitees.

### **Internal Rules of Procedure**

Expert groups usually operate in an informal setting without any formal rules of procedure. This is the case for this expert group.
