### **Selection Procedure (members)**

The members were selected according to the indications set up in the 2003 Communication on Integrated Product Policy (IPP) - Building on Environmental Life-Cycle Thinking COM(2003) 302, which states that the Commission "will also chair regular meetings where both Member States' and Stakeholders' representatives attend. These will assist the Commission in its development and implementation of IPP, as well as monitoring progress in the Member States. The Commission would suggest that the IPP Informal Network, established by Member States on their initiative, continues with its parallel task of information-sharing under the Chair of the Council Presidency. It also suggests that its membership be extended to Acceding and Candidate Countries." The criteria for participation and the list of stakeholders were discussed and finalised in the first two meetings of the IPP/SCP group in February and September 2004.
