## LIST OF CONTROL BODIES AND CONTROL AUTHORITIES IN THE ORGANIC SECTOR PROVIDED FOR IN ARTICLE 35(b) OF COUNCIL REGULATION (EC) No 834/2007

Article 27(4) of Council Regulation (EC) No 834/2007 of 28 June 2007 on organic production and labelling of organic products and repealing Regulation (EEC) No2091/92, provides that the competent authority may confer its control competences to one or more control authorities and/or delegate control tasks to one or more control bodies.

According to the provision of Article 35(b) of the Regulation and on the basis of information from Member States updated in 2013-2014, the present communication provides information on the control system set up in each Member State and the names and addresses of bodies and/or authorities approved for control, including code numbers as attributed to them by the Member States.

The code number of the control body or control authority to which the operator who has carried out the most recent production or preparation operation is subject must appear in the labelling of organic products (Article 24(1)(a) of Regulation No 834/2007).

Under the column "comments" the control system set up in each Member State is indicated as follows:

A: System of approved private control bodies

B: System of (a) designated public control authority (ies)

C: System of a designated public control authority and approved private control bodies

From January 2009 approved control bodies in the European Union must be accredited to the European Standard EN 45011 or ISO Guide 65 (Article 27 (5) (c) of Regulation No 834/2007).
