

**SUMMARY REPORT**  
**of the Joint Committee meeting of the 2<sup>nd</sup> Committee meeting for Direct payments and**  
**the 7<sup>th</sup> Rural development Committee meeting**  
**15 May 2014**

**1. CAP reform post-2013 – DSCG/2014/21 – rev. 2**

The Commission representative presented the consolidated draft Commission Implementing Regulation (EU) No .../.. laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and of the Council with regard to the integrated administration and control system, rural development measures and cross compliance with the latest substantial changes since the last Committee of 6 March 2014.

Member States raised a number of questions for which the Commission representative provided explanations. It also recalled that the intention was to request for the opinion of the Committee on this draft implementing act in June.

**2. Any other business**

The Commission representative announced that answers to the written questions of Member States as regards IACS and the implementation of the reform will from now on be published in CIRCABC.
