Subject: Summary report of the 6th Committee for direct payments held on 16/10/2014

All Member States were present.

1. INTEGRATED ADMINISTRATION AND CONTROL SYSTEM (IACS):

- (a) **Presentation and discussion of a revised draft guidance document on the establishment of the EFA-layer referred to in Article 70(2) of Regulation (EU) 1306/2013 – DSCG/2014/31_REV 2**

The Commission representative presented a REV 2 of the draft guidance document of the Commission services on the establishment of the EFA-layer referred to in Article 70(2) of R. 1306/2013 and an exchange of views took place. The document will be finalised and published shortly on CircaBC. As regards specifically the 3-years principle in respect of the establishment of the EFA-layer for EFAs for which it is not obvious whether they are stable, the Commission services committed themselves to closely monitor the issue.

- (b) **Presentation and discussion of a revised draft guidance document on the Land Parcel Identification System under Articles 5, 9 and 10 of Regulation (EU) No 640/2014 DSCG/2014/33_REV 2**

The Commission representative presented a REV 2 of the draft guidance document of the Commission services on the LPIS referred to in Articles 5, 9 and 10 of R. 640/2014 and an exchange of views took place. The document will be finalised and published shortly on CircaBC.

- (c) **Presentation and discussion of a revised draft guidance document for on-the-spot checks and area measurement, Claim Year 2015 – DSCG/2014/32_REV 1**

The Commission representative presented a REV 1 of the draft guidance document of the Commission services on on-the-spot checks and area measurements for claim year 2015. An exchange of views took place. Member states are invited to send their comments by 24 October.

2. ANY OTHER BUSINESS:

The Commission representative recalled that according to article 26 of Regulation (EU) No 908/2014 Member States shall communicate to the Commission by 1st November the images needed for the 2015 control campaign. Member States will shortly receive from the JRC the forms to be filled-in.
