1. POSEI/SMALL AEGEAN ISLANDS SCHEME

The Commission services gave information concerning in particular the "major" programme modifications presented by end of July 2015 (France and Spain) and the importance to comply with the deadline (end of September) for the presentation of 2014 annual reports, in the context of the external evaluation on POSEI/SAI scheme.

The Commission representatives presented a first part of a draft Commission Implementing Regulation amending Implementing Regulation (EU) No 809/2014 laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and of the Council with regard to the integrated administration and control system, rural development measures and cross compliance.

Member States raised a number of questions and expressed their opinion about the proposed modifications/document for which the Commission representatives provided explanations and committed to examine certain raised issues. The revised version will be presented in the next committee, which will take place on 24 September 2015.
