**Subject: Summary report of the Joint Committee meeting for direct payments (19<sup>th</sup>) and rural development (27<sup>th</sup>) held on 11/11/2015**

All Member States were present for the vote except Bulgaria, Cyprus, Luxembourg and Slovenia. Latvia was represented by Lithuania.

**1. SIMPLIFICATION - INTEGRATED ADMINISTRATION AND CONTROL SYSTEM (IACS):**

Presentation and vote on the draft Commission Implementing Act amending Implementing Regulation (EU) No 809/2014 laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and of the Council with regard to the integrated administration and control system, rural development measures and cross compliance - **DS/CDP/2015/13-Rev-4.**

The Commission representatives presented the final version of the draft Commission Implementing Regulation indicated above.

A favourable opinion was delivered by the Committee which was held in the margin of the Common Market Organisation Committee.

The adoption procedure has been launched with a foreseen date of adoption on 14 December 2015 with entering into force on the third day following the day of its publication in the Official Journal of the European Union.
