1. POSEI/SMALL AEGEAN ISLANDS SCHEME:

Presentation and vote on a draft Commission Implementing Decision approving modification to the POSEI programme presented by French authorities, in conformity with Article 40(2) of Regulation (EU) No 180/2014 - **DS/CDP/2015/18**

The Commission representative presented a draft Commission Implementing Decision approving a major modification to the POSEI programme for France – DSCG/2015/18.

The Committee delivered a positive vote, which was confirmed by written procedure on 27/11 (all Member States in favour).

The adoption procedure will be launched within a short delay.

2. INTEGRATED ADMINISTRATION AND CONTROL SYSTEM (IACS):

Presentation and exchanges of view on a Working document on the increase in the percentage of beneficiaries to be checked in the context of greening where significant non-compliances are found - **DS/CDP/2015/19**

The Commission presented the draft working document stated above. MS expressed their opinion about this document and raised questions/comments to which the Commission representatives provided explanations/clarifications. In addition, the Commission undertook the commitment to examine certain issues raised by several delegations. The updated version will be presented in the next committee for direct payments which will take place on 10 December 2015.
